A BILL

To amend title 38, United States Code, to increase the amount of veterans' burial benefit paid for plot allowances, and to provide for the payment to States of plot allowances for veterans eligible for burial in a national cemetery who are buried in cemeteries of such States.

- 1 Be it enacted by the Senate and House of Representa-
- 2 tives of the United States of America in Congress assembled,
- 3 SECTION 1. SHORT TITLE.
- 4 This Act may be cited as the "Veterans Burial Plot
- 5 Allowance Improvement Act of 1999".

| 18 | or political subdivision of a State, the Secretary shall |

| 20 | the sum of \$300 as a plot or interment allowance for |
| 21 | such veteran. |
| 22 | "(B)(i) In the case of a veteran described in |
| 23 | clause (ii) who is buried in a cemetery, or a section |
| 24 | of a cemetery, other than as described in subpara- |
| 25 | graph (A), the Secretary shall pay a sum not exceed- |

ing \$300 as a plot or interment allowance to such

1 person as the Secretary prescribes, except that if 2 any part of the plot or interment costs of a burial 3 to which this subparagraph applies has been paid or assumed by a State, an agency or political subdivi-5 sion of a State, or a former employer of the de-6 ceased veteran, no claim for such allowance shall be 7 allowed for more than the difference between the en-8 tire amount of the expenses incurred and the 9 amount paid or assumed by any or all of the fore-10 going entities.

"(ii) A veteran referred to in clause (i) is a veteran eligible for a burial allowance under section 2302 of this title, or under subsection (a), who was discharged from the active military, naval, or air service for a disability incurred or aggravated in line of duty.".

17 (b) EFFECTIVE DATE.—The amendment made by
18 subsection (a) shall take effect on the date of the enact19 ment of this Act and apply with respect to individuals
20 dying on or after such date.
