To amend title 38 of the United States Code to provide pay parity for dentists with physicians employed by the Veterans Health Administration.

- 1 Be it enacted by the Senate and House of Representa-
- 2 tives of the United States of America in Congress assembled,
- 3 SECTION 1. SHORT TITLE.
- 4 This Act may be cited as the "Put Your Money
- 5 Where Your Mouth Is—The VA Dentists Equity Act".
- 6 SEC. 2. PAY PARITY FOR DENTISTS.
- 7 (a) In General.—Section 7435(b) of title 38,
- 8 United States Code is amended—

- 1 (1) in paragraph (1), by striking "\$3,500" and 2 inserting "\$9,000";
- 3 (2) in paragraph (2)(A), by amending the table
- 4 to read as follows:

"Length of Service	Rate	
	Minimum	Maximum
2 years but less than 4 years	\$4,000	\$6,000
4 years but less than 8 years	6,000	12,000
8 years but less than 12 years	12,000	18,000
12 years or more	12,000	25,000";

- 5 (3) in paragraph (3)(A), by striking "\$20,000"
- 6 and inserting "\$40,000";
- 7 (4) in paragraph (4)(A), by amending the table
- 8 to read as follows:

"Position	Rate	
	Minimum	Maximum
Service Chief (or in a comparable position as determined by the Secretary)	\$4,500 14,500 0	\$15,000 25,000 25,000";

- 9 (5) in paragraph (4)(B), by amending the table
- to read as follows:

"Position	Rate
Deputy Service Director	\$20,000
Service Director	25,000
Deputy Assistant Under Secretary for Health	27,500
Assistant Under Secretary for Health (or in a comparable posi-	
tion as determined by the Secretary)	30,000";

- 11 (6) in paragraph (6), by striking "\$5,000" and
- 12 inserting "\$17,000"; and

- 1 (7) in paragraph (7)(A), by striking "\$5,000"
- 2 and inserting "\$15,000".
- 3 (b) Effective Date.—The amendments made by
- 4 this section shall apply to any contract entered into under
- 5 chapter 74 of title 38, United States Code, after the later
- 6 of October 1, 1999 or the date of the enactment of this

7 Act.
