A BILL

To amend title 49, United States Code, to ensure the safe operations of small commercial vans.

- 1 Be it enacted by the Senate and House of Representa-
- 2 tives of the United States of America in Congress assembled,
- 3 SECTION 1. SHORT TITLE.
- 4 This Act may be cited as the "Safe and Efficient Pas-
- 5 senger Van Act".
- 6 SEC. 2. STATE AUTHORITY TO REGULATE SMALL COMMER-
- 7 CIAL VANS.
- 8 Section 14501(a) of title 49, United States Code, is
- 9 amended by adding at the end the following:

1	"(3) Authority of states to ensure the
2	SAFE OPERATIONS OF SMALL COMMERCIAL VANS.—
3	"(A) Commercial van defined.—For
4	purposes of this paragraph, the term 'commer-
5	cial van' means a motor vehicle providing reg-
6	ular route transportation service for compensa-
7	tion and having a capacity of not more than 15
8	passengers, including the driver.
9	"(B) General Rule.—Notwithstanding
10	paragraph (1), a State may regulate operations
11	of commercial vans to ensure that such
12	operations—
13	"(i) are safe for passengers and the
14	public;
15	"(ii) only load and unload passengers
16	at locations that are safe for such pur-
17	poses;
18	"(iii) do not interfere with the flow of
19	traffic or significantly worsen road conges-
20	tion; and
21	"(iv) are limited to routes approved by
22	the States.
23	"(C) Included activities.—Exercising
24	the authority provided by subparagraph (B)
25	may include limiting the number of commercial

1	vans operating on any route and inspecting
2	such vans.
3	"(D) Delegation of Authority.—A
4	State may delegate to political subdivisions of
5	the State the authority to regulate operations of
6	commercial vans.".
7	SEC. 3. USE OF MOTOR CARRIER SAFETY GRANTS.
8	(a) In General.—Section 31102(c) of title 49,
9	United States Code, is amended by adding at the end the
10	following:
11	"(4) Oversight and enforcement of State regu-
12	lations relating to operations of commercial vans
13	issued under the authority of section 14501(a)(3).".
14	(b) Conforming Amendment.—Section 31102 of
15	such title is further amended—
16	(1) in subsection $(b)(1)$ by aligning subpara-
17	graph (A) with subparagraph (B) of such sub-
18	section;
19	(2) in subsections $(e)(1)$ and $(e)(3)$ by striking
20	"enforcement" and inserting "Enforcement"; and
21	(3) in subsection (e)(2) by striking "detection"
22	and inserting "Detection".
