## A BILL

To improve the safety of animals transported on aircraft, and for other purposes.

- 1 Be it enacted by the Senate and House of Representa-
- 2 tives of the United States of America in Congress assembled,
- 3 SECTION 1. SHORT TITLE; TABLE OF CONTENTS.
- 4 (a) SHORT TITLE.—This Act may be cited as the
- 5 "Safe Air Travel for Animals Act".

#### 1 SEC. 2. FINDINGS.

- 2 Congress finds that—
- 3 (1) animals are live, sentient creatures, with the
- 4 ability to feel pain and suffer;
- 5 (2) it is inappropriate for animals transported
- 6 by air to be treated as baggage;
- 7 (3) according to the Air Transport Association,
- 8 over 500,000 animals are transported by air each
- 9 year and as many as 5,000 of those animals are lost,
- injured, or killed;
- 11 (4) most injuries to animals traveling by air-
- plane are due to mishandling by baggage personnel,
- severe temperature fluctuations, insufficient oxygen
- in cargo holds, or damage to kennels;
- 15 (5) there are no Federal requirements that air-
- lines report incidents of animal loss, injury, or
- death:

1	(6) members of the public have no information
2	to use in choosing an airline based on its record of
3	safety with regard to transporting animals;
4	(7) the last congressional action on animals
5	transported by air was conducted over 22 years ago;
6	and
7	(8) the conditions of cargo holds of airplanes
8	must be improved to protect the health, and ensure
9	the safety, of transported animals.
10	TITLE I—ANIMAL WELFARE
11	SEC. 101. DEFINITION OF TRANSPORT.
12	Section 2 of the Animal Welfare Act (7 U.S.C. 2132)
13	is amended by adding at the end the following:
14	"(p) Transport.—The term 'transport', when used
15	with respect to the air transport of an animal by a carrier,
16	means the transport of the animal during the period the
17	animal is in the custody of the carrier, from check-in of
18	the animal prior to departure until the animal is returned
19	to the owner or guardian of the animal at the final des-
20	tination of the animal.".
21	SEC. 102. INFORMATION ON INCIDENCE OF ANIMALS IN AIR
22	TRANSPORT.
23	Section 6 of the Animal Welfare Act (7 U.S.C. 2136)
24	is amended—

1	(1) by striking "Sec. 6. Every" and inserting
2	the following:
3	"SEC. 6. REGISTRATION.
4	"(a) In General.—Each"; and
5	(2) by adding at the end the following:
6	"(b) Information on Incidence of Animals in
7	AIR TRANSPORT.—Not later than 2 years after the date
8	of enactment of this subsection, the Secretary shall require
9	each airline carrier to—
10	"(1) submit to the Secretary real-time informa-
11	tion (as the information becomes available, but at
12	least 24 hours in advance of a departing flight) on
13	each flight that will be carrying a live animal,
14	including—
15	"(A) the flight number;
16	"(B) the arrival and departure points of
17	the flight;
18	"(C) the date and times of the flight; and
19	"(D) a description of the number and
20	types of animals aboard the flight; and
21	"(2) ensure that the flight crew of an aircraft
22	is notified of the number and types of animals, if
23	any, on each flight of the crew.".

1	SEC. 103. REPORTS BY CARRIERS ON INCIDENTS INVOLV-
2	ING ANIMALS DURING AIR TRANSPORT.
3	Section 19 of the Animal Welfare Act (7 U.S.C.
4	2149) is amended by adding at the end the following:
5	"(e) Reports by Carriers on Incidents Involv-
6	ING ANIMALS DURING AIR TRANSPORT.—
7	"(1) In general.—An airline carrier that
8	causes, or is otherwise involved in or associated with,
9	an incident involving the loss, injury, death or mis-
10	handling of an animal during air transport shall
11	submit a report to the Secretary of Agriculture and
12	the Secretary of Transportation that provides a com-
13	plete description of the incident.
14	"(2) Administration.—Not later than 90
15	days after the date of enactment of this subsection,
16	the Secretary of Agriculture, in consultation with the
17	Secretary of Transportation, shall issue regulations
18	that specify—
19	"(A) the type of information that shall be
20	included in a report required under paragraph
21	(1), including—
22	"(i) the date and time of an incident;
23	"(ii) the location and environmental
24	conditions of the incident site;
25	"(iii) the probable cause of the inci-
26	dent; and

1	"(iv) the remedial action of the car-
2	rier; and
3	"(B) a mechanism for notifying the public
4	concerning the incident.
5	"(3) Consumer information.—The Secretary
6	of Transportation shall include information received
7	under paragraph (1) in the Air Travel Consumer
8	Reports and other consumer publications of the De-
9	partment of Transportation in a separate category
10	of information.
11	"(4) Consumer complaints.—Not later than
12	15 days after receiving a consumer complaint con-
13	cerning the loss, injury, death or mishandling of an
14	animal during air transport, the Secretary of Trans-
15	portation shall provide a description of the complaint
16	to the Secretary of Agriculture.".
17	SEC. 104. ANNUAL REPORTS.
18	Section 25 of the Animal Welfare Act (7 U.S.C.
19	2155) is amended in the first sentence—
20	(1) in paragraph (4), by striking "and" at the
21	end;
22	(2) in paragraph (5), by striking the period at
23	the end and inserting "; and; and
24	(3) by adding at the end the following:
25	"(6) a summary of—

1	"(A) incidents involving the loss, injury, or
2	death of animals transported by airline carriers;
3	and
4	"(B) consumer complaints regarding the
5	incidents.".

7	SEC. 201. POLICIES AND PROCEDURES FOR TRANSPORTING
8	ANIMALS.
9	(a) In General.—Subchapter I of chapter 417 of
10	title 49, United States Code, is amended by adding at the
11	end the following:

14	"An air carrier shall establish and include in each
15	contract of carriage under part 253 of title 14, Code of
16	Federal Regulations (or any successor regulation) policies
17	and procedures of the carrier for transporting animals
18	safely, including—
19	"(1) training requirements for airline personnel
20	in the proper treatment of animals being trans-
21	ported;
22	"(2) information on the risks associated with
23	air travel for animals;

24	"(3) a description of the conditions under which

1	"(4) the safety record of the carrier with re-
2	spect to transporting animals; and
3	"(5) plans for handling animals prior to and
4	after flight, and when there are flight delays or
5	other circumstances that may affect the health or
6	safety of an animal during transport.".

- "(1) IN GENERAL.—The Secretary may assess a civil penalty of not more than \$5,000 for each violation on, or issue a cease and desist order against, any carrier that causes, or is otherwise involved in or associated with, the loss, injury, or death of an animal during air transport.
- "(2) CEASE AND DESIST ORDERS.—A carrier who knowingly fails to obey a cease and desist order issued by the Secretary under this subsection shall be subject to a civil penalty of \$1,500 for each offense.
- "(3) SEPARATE OFFENSES.—For purposes of determining the amount of a penalty imposed under this subsection, each violation and each day during which a violation continues shall be a separate offense.

1	"(4) Factors.—In determining whether to as-
2	sess a civil penalty under this subsection and the
3	amount of the civil penalty, the Secretary shall
4	consider—
5	"(A) the size and financial resources of the
6	business of the carrier;
7	"(B) the gravity of the violation;
8	"(C) the good faith of the carrier; and
9	"(D) any history of previous violations by
10	the carrier.
11	"(5) Collection of Penalties.—
12	"(A) In general.—On the failure of a
13	carrier to pay a civil penalty assessed by a final
14	order under this section, the Secretary shall re-
15	quest the Attorney General to institute a civil
16	action in a district court of the United States
17	or other United States court for any district in
18	which the carrier is found or resides or trans-
19	acts business, to collect the penalty.
20	"(B) Penalties.—The court shall have
21	jurisdiction to hear and decide an action
22	brought under subparagraph (A).
23	"(c) Compensation.—If an animal is lost, injured,
24	or dies in transport by a carrier, unless the carrier proves
25	that the carrier did not cause, and was not otherwise in-

- 1 volved in or associated with, the loss, injury, or death of
- 2 the animal, the owner of the animal shall be entitled to
- 3 compensation from the carrier in an amount that—
- 4 "(1) is not less than 2 times any limitation es-
- 5 tablished by the carrier for loss or damage to bag-
- 6 gage under part 254 of title 14, Code of Federal
- Regulations (or any successor regulation); and
- 8 "(2) includes all veterinary and other related
- 9 costs that are documented and initiated not later
- than 1 year after the incident that caused the loss,
- injury, or death of the animal.".
- 12 (b) Table of Contents.—The analysis for chapter

## 15 SEC. 203. CARGO HOLD IMPROVEMENTS TO PROTECT ANI-

- 16 MAL HEALTH AND SAFETY.
- 17 (a) In General.—To protect the health and safety
- 18 of animals in transport, the Secretary of Transportation
- 19 shall—
- 20 (1) in conjunction with requiring certain trans-
- 21 port category airplanes used in passenger service to
- replace class D cargo or baggage compartments with
- class C cargo or baggage compartments under parts
- 24 25, 121, and 135 of title 14, Code of Federal Regu-

- lations, to install, to the maximum extent prac-
- 2 ticable, systems that permit positive airflow and
- 3 heating and cooling for animals that are present in
- 4 cargo or baggage compartments; and
- 5 (2) effective beginning January 1, 2001, pro-
- 6 hibit the transport of an animal by any carrier in a
- 7 cargo or baggage compartment that fails to include
- 8 a system described in paragraph (1).
- 9 (b) REPORT.—Not later than March 31, 2002, the
- 10 Secretary shall submit a report to Congress that describes
- 11 actions that have been taken to carry out subsection (a).
