To amend the Food Security Act of 1985, to give producers greater flexibility in enrolling certain marginal land in the conservation reserve, and for other purposes.

- 3 SECTION 1. ENROLLMENT OF LAND IN THE CONSERVATION
- 4 RESERVE.
- 5 (a) MAXIMUM ENROLLMENT.—Section 1231(d) of
- 6 the Food Security Act of 1985 (16 U.S.C. $3831(\mathrm{d}))$ is
- 7 amended by striking "36,400,000 acres" and inserting
- 8 "40,000,000 acres".

- 1 (b) Inclusion of Lands Adjacent to Highly
- 2 Erodible Croplands.—Section 1231 of the Food Secu-
- 3 rity Act of 1985 (16 U.S.C. 3831) is amended by adding
- 4 at the end the following new subsection:
- 5 "(h) Inclusion of Lands Adjacent to Highly
- 6 ERODIBLE CROPLANDS.—In the case of highly erodible
- 7 croplands described in subsection (b)(1) that are eligible
- 8 for enrollment in the conservation reserve, the Secretary
- 9 may permit the owner or operator of the lands to include
- 10 a small quantity of additional acreage (not otherwise eligi-
- 11 ble for enrollment in the reserve) as part of the parcel
- 12 to be enrolled if—
- "(1) the additional land is located adjacent to
- the eligible highly erodible croplands;
- 15 "(2) it is not economically viable to use the ad-
- ditional land as cropland given the enrollment of the
- adjacent highly erodible croplands; and
- 18 "(3) the resulting parcel does not exceed 30
- 19 acres.".
