## 1 SECTION 1. UNITED STATES POLICY REGARDING JERU-

- 2 SALEM AS THE CAPITAL OF ISRAEL.
- 3 (a) Limitation on Operation of Consulate in
- 4 Jerusalem.—Notwithstanding any other provision of
- 5 law, the United States shall not operate a United States
- 6 consulate or diplomatic facility in Jerusalem unless such
- 7 consulate or diplomatic facility is under the supervision
- 8 of the United States Ambassador to Israel.
- 9 (b) Identification of Jerusalem as the Cap-
- 10 ITAL OF ISRAEL IN OFFICIAL GOVERNMENT DOCU-
- 11 MENTS.—Notwithstanding any other provision of law, any

- (c) Record of Place of Birth as Israel for
