Ms. NORTON (for herself and Mr. WYNN) introduced the following bill; which
was referred to the Committee on the Judiciary

A BILL

To assist local governments in conducting gun buyback
programs.

1 *Be it enacted by the Senate and House of Representa-*
2 *tives of the United States of America in Congress assembled,*

3 **SECTION 1. SHORT TITLE.**

4 This Act may be cited as the “Nationwide Gun
5 Buyback Act of 1999”.

6 **SEC. 2. GRANT PROGRAM.**

7 (a) IN GENERAL.—The Attorney General of the
8 United States may make grants to units of local govern-
9 ment to conduct gun buyback programs.

10 (b) REDUCTION OF INCIDENCE OF GUN VIOLENCE
11 TO BE GIVEN GREAT WEIGHT.—In assessing applications

1 for grants under this Act, the Attorney General shall give
2 greater weight to the incidence of gun violence and the
3 need to reduce the availability of guns in the jurisdictions
4 involved than to any other factors.

5 (c) USE OF FUNDS.—A unit of local government to
6 which a grant is made under this Act shall use the grant
7 only to conduct a gun buyback program in accordance
8 with the approved application for the grant.

9 **SEC. 3. APPLICATIONS.**

10 (a) IN GENERAL.—The chief executive of a unit of
11 local government desiring a grant under this Act shall sub-
12 mit to the Attorney General of the United States an appli-
13 cation for the grant, which shall be in such form and con-
14 tain such information as the Attorney General may rea-
15 sonably require.

16 (b) REQUIREMENTS.—An application for a grant
17 under this Act for a gun buyback program shall contain
18 assurances from the chief executive of the unit of local
19 government (after consultation with the local chief of po-
20 lice or equivalent officer) that—

21 (1) within 30 days after the date the program
22 collects a gun, the gun will be destroyed or, if the
23 gun is an inoperable curio or relic with historic sig-
24 nificance, donated to a museum for display;

1 (2) the local law enforcement authority is able
2 to collect guns safely under the program; and

3 (3) the unit of local government has the author-
4 ity to grant an appropriate amnesty to persons from
5 whom guns are obtained under the program.

6 (c) REGULATIONS.—Not later than 90 days after the
7 date of the enactment of this Act, the Attorney General
8 of the United States shall promulgate regulations to im-
9 plement this Act, which shall specify the information that
10 must be included in an application for a grant under this
11 Act, and the requirements that units of local government
12 must meet to be eligible for such a grant.

13 **SEC. 4. DEFINITIONS.**

14 In this Act:

15 (1) GUN.—The term “gun” means a firearm
16 (as defined in section 921(a)(3) of title 18, United
17 States Code).

18 (2) GUN BUYBACK PROGRAM.—The term “gun
19 buyback program” means a program conducted by a
20 local law enforcement authority under which the au-
21 thority purchases guns from, or accepts gun dona-
22 tions made by individuals or groups desiring to dis-
23 pose of guns.

1 **SEC. 5. LIMITATIONS ON AUTHORIZATION OF APPROPRIA-**
2 **TIONS.**

3 For grants under this Act, there are authorized to
4 be appropriated to the Attorney General of the United
5 States not more than \$50,000,000 for each fiscal year.
