## A BILL

To provide regulatory relief for small business concerns, and for other purposes.

- 1 Be it enacted by the Senate and House of Representa-
- 2 tives of the United States of America in Congress assembled,
- 3 SECTION 1. SHORT TITLE.
- 4 This Act may be cited as the "National Small Busi-
- 5 ness Regulatory Assistance Act of 1999".
- 6 SEC. 2. PURPOSE.
- 7 The purpose of this Act is to establish a system of
- 8 confidential voluntary compliance with Federal regulations
- 9 that will—

1	(1) provide a low-cost process to significantly
2	improve voluntary compliance by small business con-
3	cerns with Federal regulations;
4	(2) improve the level of outreach to the small
5	business community and reduce duplication of effort
6	among Federal agencies;
7	(3) be funded without additional appropriations;
8	(4) provide a mechanism for unbiased feedback
9	to Federal agencies on the small business regulatory
10	environment; and
11	(5) partner nonpunitive compliance assistance
12	programs with the small business development cen-
13	ter service delivery network in order to improve ac-
14	cess to and utilization of these programs by the
15	small business community.
16	SEC. 3. ESTABLISHMENT OF PROGRAM.
17	The Small Business Act (15 U.S.C. 637 et seq.) is
18	amended—
19	(1) by redesignating section 32 as section 33;
20	and
21	(2) by inserting after section 31 the following
22	new section:
23	"SEC. 32. SMALL BUSINESS REGULATORY RELIEF.
24	"(a) Definitions.—For purposes of this section—
25	"(1) the term 'participating agency' means—

1	"(A) the Environmental Protection Agen-
2	cy;
3	"(B) the Internal Revenue Service of the
4	Department of the Treasury; and
5	"(C) the Department of Labor;
6	"(2) the term 'small business development cen-
7	ter' means a small business development center es-
8	tablished pursuant to section 21;
9	"(3) the term 'system of voluntary compliance'
10	means the system under which small business devel-
11	opment centers or consortia of small business devel-
12	opment centers provide confidential assistance to one
13	or more small business concerns in achieving vol-
14	untary compliance with regulatory requirements im-
15	posed on small business concerns by a participating
16	agency; and
17	"(4) the term 'compliance assistance plan'
18	means a five year plan jointly developed and annu-
19	ally revised by each participating agency, the Office
20	of Small Business Development Centers for the
21	Small Business Administration, and representatives
22	of an association representing a majority of small
23	business development centers for the establishment
24	and maintenance of a system of voluntary compli-
25	ance.

1	"(b) Duties of Participating Agencies.—
2	"(1) COMPLIANCE ASSISTANCE PLAN.—Not
3	later than 90 days after the date of enactment of
4	this Act and annually thereafter, each participating
5	agency, the Office of Small Business Development
6	Centers of the Small Business Administration, and
7	representatives of an association representing a ma-
8	jority of small business development centers shall
9	agree to a compliance assistance plan.
10	"(2) Contents of compliance assistance
11	PLAN.—Each compliance assistance plan agreed to
12	under paragraph (1) shall include—
13	"(A) regulatory compliance objectives of
14	the participating agency;
15	"(B) regulatory compliance priorities of
16	the participating agency;
17	"(C) identification of the types of services.
18	materials, and resources to be developed or
19	used by the participating agency;
20	"(D) identification of participating agency
21	facilities, expertise, and other resources that
22	may be accessed by the Office of Small Busi-
23	ness Development Centers of the Small Busi-
24	ness Administration, a small business develop-
25	ment center, or a small business concern par-

1	ticipating in the system of voluntary compliance
2	established under this section; and
3	"(E) performance outcome measures and
4	evaluation criteria to be used by the participat-
5	ing agency in evaluating the effectiveness of the
6	system of voluntary compliance to be estab-
7	lished under this section.
8	"(3) Duplication of Effort.—In carrying
9	out this subsection, each participating agency shall,
10	to the maximum extent practicable, ensure that the
11	participating agencies do not duplicate efforts.
12	"(4) Enforcement.—The participating agen-
13	cy, the Department of Justice, or any other Federal
14	agency shall consider a small business concern par-
15	ticipating in the system of voluntary compliance in
16	full compliance, if the small business concern fulfills
17	the regulatory compliance objectives and priorities
18	established in the compliance assistance plans sub-
19	mitted under subsection (b)(1).
20	"(c) Duties of the Office of Small Business
21	DEVELOPMENT CENTERS.—
22	"(1) Implementation and administration
23	OF COMPLIANCE ASSISTANCE PLANS.—
24	"(A) In general.—Based on each compli-
25	ance assistance plan agreed to under subsection

1 (b)(1), not later than 180 days after the date 2 of enactment of this Act, the Office of Small 3 Business Development Centers, with the agree-4 ment of an association representing the majority of small business development centers, shall 6 develop and publish guidelines for the establish-7 ment by small business development centers or 8 consortia of small business development centers 9 of a system of voluntary compliance in accord-10 ance with this section.

- "(B) GUIDELINE REQUIREMENTS.—The guidelines published under subparagraph (A) shall—
  - "(i) establish priorities for the types of assistance to be provided to small business concerns under the system of voluntary compliance established by small business development centers or consortia of small business development centers under this section; and
  - "(ii) establish standards relating to educational, technical, and support services required by small business development centers or consortia of small business de-

1	velopment centers to provide a system of
2	voluntary compliance.
3	"(C) Program delivery.—The guidelines
4	established under subparagraph (A) shall—
5	"(i) require that the assistance to
6	small business concerns participating in
7	the system of voluntary compliance under
8	this section be carried out by small busi-
9	ness development centers or by consortia of
10	small business development centers who
11	shall, to the maximum extent practicable,
12	access other existing Federal and State
13	non-punitive, compliance and technical as-
14	sistance programs, including, but not lim-
15	ited to, the technical and environmental
16	compliance assistance programs established
17	under section 507 of the Clean Air Act
18	Amendments of 1990; and
19	"(ii) provide that certain national
20	service delivery support requirements be
21	carried out under contract with an associa-
22	tion representing the majority of small
23	business development centers.
24	"(D) ISSUANCE OF GRANT.—Not later
25	than 150 days after the submission of work

1	plans under subsection $(d)(1)$ , the Office of
2	Small Business Development Centers shall issue
3	a grant to each small business development cen-
4	ter or each consortium of small business devel-
5	opment centers to carry out the system of vol-
6	untary compliance.
7	"(d) Duties of Small Business Development
8	Centers.—
9	"(1) Work Plan.—Beginning not later than
10	60 days after the date on which the guidelines are
11	published by the Office of Small Business Develop-
12	ment Centers under subsection $(c)(1)(A)$ , each small
13	business development center or consortium of small
14	business development centers shall, on an annual
15	basis, submit to the Office of Small Business Devel-
16	opment Centers a work plan under which the small
17	business development center will carry out the sys-
18	tem of voluntary compliance in accordance with such
19	guidelines.
20	"(2) Assistance Provided.—The assistance
21	to small business concerns participating in the sys-
22	tem of voluntary compliance shall include—
23	"(A) access to information and resources;
24	"(B) training and educational activities;

1	"(C) confidential, free-of-charge, one-on-
2	one in-depth counseling; and
3	"(D) technical assistance.
4	"(3) Reports; recommendations.—
5	"(A) Each small business development cen-
6	ter and consortium of small business develop-
7	ment centers shall, on an annual basis, submit
8	to the Office of Small Business Development
9	Centers of the Small Business Administration a
10	report on the assistance provided by the small
11	business development center or consortia estab-
12	lished under the system of voluntary compliance
13	established under this section.
14	"(B) No small business development cen-
15	ter, consortium of small business development
16	centers, or any person relied on by any such
17	small business development center shall be re-
18	quired to provide services or to disclose the
19	name or address of any small business concern
20	participating in a system of voluntary compli-
21	ance under this section.
22	"(C) Subparagraph (B) shall not be con-
23	strued to prevent the Office of Inspector Gen-
24	eral of the Administration from auditing a

small business development center, consortium

1	of small business development centers, or any
2	person relied on by any such small business de-
3	velopment center.
4	"(e) Evaluations.—
5	"(1) Annual Report.—The Office of Smal
6	Business Development Centers of the Small Busi-
7	ness Administration shall, on an annual basis, sub-
8	mit to the President and to the Committees or
9	Small Business of the Senate and the House of Rep-
10	resentatives a report, which shall include—
11	"(A) a description of the types of assist
12	ance provided by small business development
13	centers and consortia of small business develop-
14	ment centers to small business concerns partici-
15	pating in the system of voluntary compliance;
16	"(B) the level of outreach to small business
17	concerns achieved by small business develop-
18	ment centers and consortia of small business
19	development centers under this section; and
20	"(C) recommendations for improvements in
21	the regulation of small business concerns par-
22	ticipating in the system of voluntary compli-
23	ance.
24	"(2) Independent national assessment.—
25	Upon the expiration of the three-year period begin

1 ning on the date on which the majority of small 2 business development centers and consortia of small 3 business development centers have received grants to begin implementation of the work plans described 5 under subsection (d)(1), the Council shall provide 6 for an evaluation of the system of voluntary compli-7 ance established under this section by an independ-8 ent third party which shall be submitted to the 9 President and to the Committees on Small Business 10 of the Senate and House of Representatives. 11 "(f) Funding.— 12 "(1) In general.—To assist the Office of 13 Small Business Development Centers of the Small 14 Business Administration in fostering, promoting, de-15 veloping, and carrying out the system of voluntary 16 compliance under this section— "(A) of the total amount provided to the 17 18 Department of Labor— 19 "(i) not less than 0.10 percent shall 20 be made available for obligation and ex-21 penditure by the Office of Small Business

11	"(iii) not less than 0.18 percent shall
12	be made available for obligation and ex-
13	penditure by the Office of Small Business
14	Development Centers of the Small Busi-
15	ness Administration for the implementa-
16	tion and administration of the worker safe-
17	ty and health compliance assistance plans
18	in fiscal year 2002; and
19	"(iv) not less than 0.22 percent shall
20	be made available for obligation and ex-
21	penditure by the Office of Small Business
22	Development Centers of the Small Busi-
23	ness Administration for the implementa-
24	tion and administration of the worker safe-
25	ty and health compliance assistance plans

1	in each of the fiscal years 2003 and 2004;
2	and
3	"(B) of the total amount provided to the
4	Environmental Protection Agency—
5	"(i) not less than 0.20 percent shall
6	be made available for obligation and ex-
7	penditure by the Office of Small Business
8	Development Centers of the Small Busi-
9	ness Administration for the implementa-
10	tion and administration of the compliance
11	assistance plans in fiscal year 2000;
12	"(ii) not less than 0.24 percent shall
13	be made available for obligation and ex-
14	penditure by the Office of Small Business
15	Development Centers of the Small Busi-
16	ness Administration for the implementa-
17	tion and administration of the compliance
18	assistance plans in fiscal year 2001;
19	"(iii) not less than 0.29 percent shall
20	be made available for obligation and ex-
21	penditure by the Office of Small Business
22	Development Centers of the Small Busi-
23	ness Administration for the implementa-
24	tion and administration of the compliance
25	assistance plans in fiscal year 2002; and

1	"(iv) not less than 0.35 percent shall
2	be made available for obligation and ex-
3	penditure by the Office of Small Business
4	Development Centers of the Small Busi-
5	ness Administration for the implementa-
6	tion and administration of the compliance
7	assistance plans in fiscal year 2003; and
8	"(C) of the total amount provided to the
9	Internal Revenue Service of the Department of
10	the Treasury—
11	"(i) not less than 0.25 percent shall
12	be made available for obligation and ex-
13	penditure by the Office of Small Business
14	Development Centers of the Small Busi-
15	ness Administration for the implementa-
16	tion and administration of the compliance
17	assistance plans in fiscal year 2000;
18	"(ii) not less than 0.31 percent shall
19	be made available for obligation and ex-
20	penditure by the Office of Small Business
21	Development Centers of the Small Busi-
22	ness Administration for the implementa-
23	tion and administration of the compliance
24	assistance plans in fiscal year 2001;

1 "(iii) not less than 0.39 percent shall
2 be made available for obligation and ex3 penditure by the Office of Small Business
4 Development Centers of the Small Busi5 ness Administration for the implementa6 tion and administration of the compliance
7 assistance plans in fiscal year 2002; and
8 "(iv) not less than 0.49 percent shall

"(iv) not less than 0.49 percent shall be made available for obligation and expenditure by the Office of Small Business Development Centers of the Small Business Administration for the implementation and administration of the compliance assistance plans in each of the fiscal years 2003 and 2004.

#### "(2) Distribution of Assistance.—

"(A) IN GENERAL.—Amounts made available for the system of voluntary compliance under paragraph (1) shall be distributed by the Office of Small Business Development Centers to the network of small business development centers in each State or in each consortium in accordance with subparagraphs (B), (C), and (D).

1	"(B) Population based funding for-
2	MULA.—The network of small business develop-
3	ment centers in each State shall receive a dis-
4	tribution under subparagraph (A) that is equal
5	to the sum of—
6	"(i) the pro rata share of the State of
7	the total amount distributed by the Office
8	of Small Business Development Centers
9	under subparagraph (A), based upon the
10	population of the State as compared to the
11	total population in the United States, as
12	determined by the Office of Small Business
13	Development Centers; and
14	"(ii) \$300,000 for each participating
15	State.
16	"(C) Exemption from matching re-
17	QUIREMENT.—Funds provided under this sec-
18	tion shall not be subject to the matching funds
19	or eligibility requirements of section 21(a)(4).
20	"(D) CERTIFICATION REQUIREMENT.—
21	After September 30, 2000, the Office of Small
22	Business Development Centers may not provide
23	any funds under this section to a small business
24	development center or a consortium of small
25	business development centers unless the center

has, or centers within the consortium have, been approved under the certification program conducted pursuant to section (21)(k)(2), except that the Associate Administrator for Small Business Development Centers may waive such certification requirement, in the discretion of the Associate Administrator, upon showing that the center is making a good faith effort to obtain certification.

"(E) Administrative costs.— Not more than 2 percent of the amounts made available for the system of voluntary compliance under subsection (f) shall be used by the Office of Small Business Development Centers for administration, evaluation, and reporting costs.".
