A BILL

To amend title 18, United States Code, with regard to prison commissaries, and for other purposes.

- 1 Be it enacted by the Senate and House of Representa-
- 2 tives of the United States of America in Congress assembled,
- 3 SECTION 1. SHORT TITLE.
- 4 This Act may be cited as the "Federal Telephone
- 5 Abuse Reduction Act of 1999".
- 6 SEC. 2. ADMINISTRATION OF FEDERAL PRISON COM-
- 7 MISSARIES.
- 8 (a) Implementation of Inspector General Rec-
- 9 OMMENDATIONS.—The Bureau of Prisons shall implement

- 1 and follow the recommendations contained in the report
- 2 entitled "Criminal Calls: A Review of the Bureau of Pris-
- 3 ons' Management of Inmate Telephone Privileges" made
- 4 by the Inspector General of the Department of Justice in
- 5 August of 1999.
- 6 (b) General Revision and Reenactment of Sec-
- 7 TION 4043.—Section 4043 of title 18, United States Code,
- 8 is amended to read as follows:

9 "§ 4043. Prison commissary administration

- 10 "(a) The Director of the Bureau of Prisons may es-
- 11 tablish, operate, and maintain commissaries in Federal
- 12 penal or correctional facilities, from and through which ar-
- 13 ticles and services may be procured, sold, rendered, or oth-
- 14 erwise provided or made available for the benefit of in-
- 15 mates confined within those facilities. Only those articles
- 16 or services authorized by the Director of the Bureau of
- 17 Prisons may be procured from or through prison com-
- 18 missaries for the use of inmates.
- 19 "(b) There is established in the Treasury of the
- 20 United States a revolving fund to be known as the Prison
- 21 Commissary Fund, which shall be available to the Bureau
- 22 of Prisons without fiscal year limitation to carry out the
- 23 purposes, functions, and powers authorized by this section.
- 24 Funds currently on deposit in the "Commissary funds,

- 1 Federal prisons" account of the Treasury shall be trans-
- 2 ferred to the Prison Commissary Fund.
- 3 "(c) The Director of the Bureau of Prisons may ac-
- 4 cept gifts or bequests of money for credit to the Fund.
- 5 The Director may also accept gifts or bequests of other
- 6 property, real or personal, for use or other disposition by
- 7 the Bureau of Prisons. A gift or bequest under this section
- 8 is a gift or bequest to or for the use of the United States
- 9 under the Internal Revenue Code of 1986 (26 U.S.C. 1
- 10 et seq.).
- 11 "(d) Amounts in the Prison Commissary Fund that
- 12 are not needed for operations shall be kept on deposit or
- 13 invested in obligations of, or guaranteed by, the United
- 14 States and all earnings on such investments shall be de-
- 15 posited in the Prison Commissary Fund.
- 16 "(e) There shall be deposited in the Fund, subject
- 17 to withdrawal by the Bureau of Prisons—
- 18 "(1) revenues received from the sale of articles
- through prison commissaries;
- 20 "(2) revenues received from services rendered
- 21 by prison commissaries;
- 22 "(3) a gift or bequest of money for credit to the
- Fund;

- 1 "(4) proceeds from the sale or disposal of do-
- 2 nated property, real or personal, for credit to the
- Fund; and
- 4 "(5) earnings or interest that may be derived
- 5 from investments of the Fund.
- 6 "(f)(1) The Fund shall be available for the payment
- 7 of any expenses incurred by the Bureau of Prisons in es-
- 8 tablishing, operating, and maintaining prison com-
- 9 missaries, including the employment of personnel, the pur-
- 10 chase of equipment, security-related or otherwise, and
- 11 those expenses incurred in the provision of articles or serv-
- 12 ices procured, sold, rendered, or otherwise provided or
- 13 made available to inmates.
- 14 "(2) The Director of the Bureau of Prisons may use
- 15 amounts from the Prison Commissary Fund for any pur-
- 16 pose, including expenditures for programs, goods, and
- 17 services, that benefits the general welfare of inmates. No
- 18 inmate shall be entitled to any portion of the Fund.
- 19 "(g) Employees compensated by or through the Pris-
- 20 on Commissary Fund may be assigned additional duties
- 21 other than those directly related to commissary activities.
- 22 "(h) Sections 554 and 555 and 701 through 706 of
- 23 title 5, United States Code, do not apply to the making
- 24 of any determination, decision, or order under this sec-
- 25 tion.".

- 1 (c) Conforming Amendment.—Section 1321(a) of
- 2 title 31, United States Code, is amended by striking
- 3 "Commissary funds, Federal prisons".
- 4 (d) CLERICAL AMENDMENT.—The item in the table
- 5 of sections for chapter 303 of title 18, United States Code,
- 6 that relates to section 4043 is amended to read as follows: "4043. Prison commissary administration.".
