A BILL

To direct the Secretary of the Interior to make certain adjustments to the boundaries of Biscayne National Park in the State of Florida, and for other purposes.

1 *Be it enacted by the Senate and House of Representa-*
2 *tives of the United States of America in Congress assembled,*

1 **SECTION 1. TRANSFER OF PROPERTY.**

2 (a) *IN GENERAL.*—If the State of Florida transfers all
3 right, title, and interest of that State in and to the sub-
4 merged lands depicted for transfer to the United States on
5 the map entitled “Boundary Map, Biscayne National Park,
6 Stiltsville”, numbered ____, and dated ____, 2000, the Sec-
7 retary of the Interior shall immediately thereafter transfer
8 to the State of Florida, all right, title, and interest of the
9 United States in and to the approximately equal acres of
10 property depicted on that map for transfer to the State of
11 Florida.

12 (b) *MAP AND LEGAL DESCRIPTION.*—The map referred
13 to in subsection (a) and legal descriptions of the property
14 authorized to be transferred by subsection (a) shall be on
15 file and available for public inspection in the offices of the
16 National Park Service, Department of the Interior. The
17 map and legal descriptions shall have the same force and
18 effect as if included in this Act, except that the Secretary
19 of the Interior may correct clerical and typographical errors
20 in the map and legal descriptions.

21 (c) *ADJUSTMENT OF PARK BOUNDARIES.*—Property
22 transferred to the United States pursuant to subsection (a)
23 shall become, and be administered as, part of the Biscayne
24 National Park after such transfer. Property transferred to
25 the State of Florida pursuant to subsection (a) shall not
26 be part of the Biscayne National Park after such transfer.

- 1 *As soon as practicable after such property is transferred,*
- 2 *the Secretary shall adjust the boundaries of the Biscayne*
- 3 *National Park to reflect the transfer.*
