- 3 SECTION 1. CERTAIN COINS NOT TREATED AS COLLECT-
- 4 IBLES.
- 5 (a) In General.—Subparagraph (A) of section
- 6 408(m)(3) of the Internal Revenue Code of 1986 (relating
- 7 to exception for certain coins and bullion) is amended to
- 8 read as follows:

1	"(A) any coin certified by a recognized
2	grading service and traded on a nationally rec-
3	ognized electronic network, or listed by a recog-
4	nized wholesale reporting service, and—
5	"(i) which is or was at any time legal
6	tender in the United States, or
7	"(ii) issued under the laws of any
8	State, or".
9	(b) Effective Date.—The amendment made by
10	this section shall apply to taxable years beginning after
11	December 31, 1998.
