A BILL

To amend the Solid Waste Disposal Act to prevent the release of hazardous waste due to flooding, and for other purposes.

- 1 Be it enacted by the Senate and House of Representa-
- 2 tives of the United States of America in Congress assembled,
- 3 SECTION 1. TREATMENT, STORAGE AND DISPOSAL OF HAZ-
- 4 ARDOUS WASTE IN FLOOD PLAINS.
- 5 Section 3004(a) of the Solid Waste Disposal Act (42
- 6 U.S.C. 6924(a)) is amended by adding the following at
- 7 the end thereof: "The standards under paragraph (4) shall
- 8 prohibit the issuance of a permit under section 3005 after

- 1 the enactment of this sentence for any hazardous waste
- 2 treatment, storage, or disposal facility to be located in a
- 3 flood plain if such facility is a major facility (as deter-
- 4 mined by the Environmental Protection Agency).".

5 SEC. 2. STUDY OF 100-YEAR FLOOD RULE.

- 6 The Administrator of the Environmental Protection
- 7 Agency shall conduct a study of the 100-year flood criteria
- 8 contained in regulations under subtitle C of the Solid
- 9 Waste Disposal Act (42 U.S.C. 6921 and following) re-
- 10 garding the location of hazardous waste treatment, stor-
- 11 age, and disposal facilities. Such study shall investigate
- 12 whether such criteria is adequate to protect human health
- 13 and the environment from the release of hazardous waste
- 14 due to flooding at such facilities. The Administrator shall
- 15 submit a report to Congress containing the results of such
- 16 study and investigation.

17 SEC. 3. LABELLING OF HAZARDOUS WASTE CONTAINERS.

- 18 Section 3002(a)(2) of the Solid Waste Disposal Act
- 19 (42 U.S.C. 6922) is amended by adding the following at
- 20 the end thereof: "and insure that the information labels
- 21 will remain in place and visible during transportation and
- 22 storage in the event of flood or other natural disaster".

1 SEC. 4. NOTIFICATION OF HAZARDOUS SUBSTANCES

- 2 PRESENT IN FLOOD PLAIN AREAS.
- 3 Section 312(d)(1)(B)(iii) of the Superfund Amend-
- 4 ments and Reauthorization Act of 1986 (42 U.S.C.
- 5 11022(d)(1)(B)(iii)) is amended by adding the following
- 6 at the end thereof: "Such location information shall in-
- 7 clude a statement of whether or not the hazardous chemi-
- 8 cals are located in a flood plain area, as defined by the
- 9 Administrator in rules promulgated by the Administrator
- 10 for purposes of section 3004(a)(4) of the Solid Waste Dis-
- 11 posal Act.".
