# A BILL

To amend title 5, United States Code, to establish a new method for fixing rates of basic pay for administrative appeals judges, and for other purposes.

- 1 Be it enacted by the Senate and House of Representa-
- 2 tives of the United States of America in Congress assembled,
- 3 SECTION 1. PAY FOR ADMINISTRATIVE APPEALS JUDGES.
- 4 (a) In General.—Title 5, United States Code, is
- 5 amended by inserting after section 5372a the following:
- 6 "§ 5372b. Administrative appeals judges
- 7 "(a) For the purpose of this section—
- 8 "(1) the term 'administrative appeals judge po-
- 9 sition' means a position the duties of which pri-

- 1 marily involve reviewing decisions of administrative
- 2 law judges appointed under section 3105; and
- 3 "(2) the term 'agency' means an Executive
- 4 agency, as defined by section 105, but does not in-
- 5 clude the General Accounting Office.
- 6 "(b) Subject to such regulations as the Office of Per-
- 7 sonnel Management may prescribe, the head of the agency
- 8 concerned shall fix the rate of basic pay for each adminis-
- 9 trative appeals judge position within such agency which
- 10 is not classified above GS-15 pursuant to section 5108.
- 11 "(c) A rate of basic pay fixed under this section shall
- 12 be—
- "(1) not less than the minimum rate of basic
- pay for level AL-3 under section 5372; and
- 15 "(2) not greater than the maximum rate of
- basic pay for level AL-3 under section 5372.".
- 17 (b) AMENDMENT TO SECTION 7323.—Section
- 18 7323(b)(2)(B)(ii) of title 5, United States Code, is amend-
- $19\,$  ed by striking "or 5372a " and inserting "5372a, or
- 20 5372b".
- 21 (c) Clerical Amendment.—The table of sections
- 22 for chapter 53 of title 5, United States Code, is amended
- 23 by inserting after the item relating to section 5372a the
- 24 following:

<sup>&</sup>quot;5372b. Administrative appeals judges.".

#### 1 SEC. 2. APPLICABILITY.

- The amendment made by section 1(a) shall apply
- 3 with respect to pay for service performed on or after the
- 4 first day of the first applicable pay period beginning on
- 5 or after—
- 6 (1) the 120th day after the date of enactment
- 7 of this Act; or
- 8 (2) if earlier, the effective date of regulations
- 9 prescribed by the Office of Personnel Management
- to carry out such amendment.
