To name certain facilities of the United States Postal Service in Baltimore, Maryland.

1       *Be it enacted by the Senate and House of Representa-*  
2       *tives of the United States of America in Congress assembled,*

3       **SECTION 1. SAMUEL H. LACY, SR. POST OFFICE.**

4       (a) DESIGNATION.—The United States post office lo-  
5       cated at 919 West 34th Street in Baltimore, Maryland,  
6       shall be known and designated as the “Samuel H. Lacy,  
7       Sr. Post Office”.

8       (b) REFERENCES.—Any reference in a law, map, reg-  
9       ulation, document, paper, or other record of the United

1 States to the facility referred to in subsection (a) shall  
2 be deemed to be a reference to the “Samuel H. Lacy, Sr.  
3 Post Office”.

4 **SEC. 2. JUDGE ROBERT BERNARD WATTS, SR. POST OFFICE.**

5 (a) DESIGNATION.—The United States post office lo-  
6 cated at 3500 Dolfield Avenue in Baltimore, Maryland,  
7 shall be known and designated as the “Judge Robert Ber-  
8 nard Watts, Sr. Post Office”.

9 (b) REFERENCES.—Any reference in a law, map, reg-  
10 ulation, document, paper, or other record of the United  
11 States to the facility referred to in subsection (a) shall  
12 be deemed to be a reference to the “Judge Robert Bernard  
13 Watts, Sr. Post Office”.

14 **SEC. 3. DR. FLOSSIE McCLAIN DEDMOND POST OFFICE.**

15 (a) DESIGNATION.—The United States post office lo-  
16 cated at 1908 North Ellamont Street in Baltimore, Mary-  
17 land, shall be known and designated as the “Dr. Flossie  
18 McClain Dedmond Post Office”.

19 (b) REFERENCES.—Any reference in a law, map, reg-  
20 ulation, document, paper, or other record of the United  
21 States to the facility referred to in subsection (a) shall  
22 be deemed to be a reference to the “Dr. Flossie McClain  
23 Dedmond Post Office”.

1 **SEC. 4. JUDGE HARRY AUGUSTUS COLE POST OFFICE.**

2 (a) DESIGNATION.—The United States post office lo-  
3 cated at 900 East Fayette Street in Baltimore, Maryland,  
4 shall be known and designated as the “Judge Harry Au-  
5 gustus Cole Post Office”.

6 (b) REFERENCES.—Any reference in a law, map, reg-  
7 ulation, document, paper, or other record of the United  
8 States to the facility referred to in subsection (a) shall  
9 be deemed to be a reference to the “Judge Harry Augus-  
10 tus Cole Post Office”.

11 **SEC. 5. FREDERICK L. DEWBERRY, JR. POST OFFICE.**

12 (a) DESIGNATION.—The United States post office lo-  
13 cated at 1001 Frederick Road in Baltimore, Maryland,  
14 shall be known and designated as the “Frederick L. Dew-  
15 berry, Jr. Post Office”.

16 (b) REFERENCES.—Any reference in a law, map, reg-  
17 ulation, document, paper, or other record of the United  
18 States to the facility referred to in subsection (a) shall  
19 be deemed to be a reference to the “Frederick L. Dew-  
20 berry, Jr. Post Office”.
