A BILL

To reduce restrictions on broadcast ownership and to improve diversity of broadcast ownership.

- 1 Be it enacted by the Senate and House of Representa-
- 2 tives of the United States of America in Congress assembled,
- 3 SECTION 1. SHORT TITLE.
- 4 This Act may be cited as the "Free Television Viabil-
- 5 ity Act of 1999".
- 6 SEC. 2. IMMEDIATE INCREASE IN NATIONAL AUDIENCE
- 7 REACH LIMITS ON BROADCAST OWNERSHIP.
- 8 The Federal Communications Commission shall mod-
- 9 ify its rules for multiple ownership set forth in section
- 10 73.3555 of its regulations (47 C.F.R. 73.3555) by increas-

- 1 ing the national audience reach limitation for television
- 2 stations to 40 percent.
- 3 SEC. 3. ADDITIONAL AUDIENCE REACH INCREASES CON-
- 4 TINGENT ON INCREASED DIVERSITY.
- 5 (a) IN GENERAL.—In connection with an application
- 6 for the assignment or transfer of a television broadcast
- 7 station license, the Federal Communications
- 8 Commission—
- 9 (1) shall increase the national audience reach
- limitation established pursuant to section 2 by an
- additional 5 percent, if the Commission determines,
- on the date of the filing of such application, that
- there is in effect a private or governmental program
- that has had the effect of increasing ownership of
- television broadcast stations by members of minority
- 16 groups; and
- 17 (2) may further increase such limitation by an
- additional 5 percent in connection with such applica-
- tion, unless the Commission determines that a direct
- correlation exists between lack of ownership of tele-
- vision broadcast stations by members of minority
- 22 groups and increasing the limitation under para-
- 23 graph (1).
- 24 (b) REGULATIONS.—The Commission shall prescribe
- 25 such regulations (or amendments to its regulations) as

- 1 may be necessary to carry out this section within 180 days
- 2 after the date of enactment of this Act.
- 3 (e) Definition.—As used in this section, the term
- 4 "member of a minority group" means an individual who
- 5 belongs to one or more of the following ethnic groups:
- 6 American Indians and Alaskan Natives; Asian and Pacific
- 7 Islanders; Blacks not of Hispanic origin; and Hispanics.
- 8 SEC. 4. EVALUATION OF PROGRAM.
- 9 Within 180 days after any two or more television
- 10 broadcast station owners have reached the national audi-
- 11 ence reach limitation established under section 3(a), the
- 12 Federal Communications Commission shall conduct a
- 13 study of the impact of raising such limitation on the entry
- 14 of small businesses and members of minority groups into
- 15 television broadcasting. The Commission shall submit a
- 16 report on such study to the Committee on Commerce of
- 17 the House of Representatives and the Committee on Com-
- 18 merce, Science, and Transportation of the Senate not later
- 19 than the expiration of such 180-day period.
- 20 SEC. 5. PRIORITY FOR NON-ENGLISH BROADCASTING STA-
- 21 TIONS.
- In making any assignments of licenses for the use
- 23 of spectrum that is returned to the Federal Communica-
- 24 tions Commission for allocation and assignment under sec-
- 25 tion 336(c) of the Communications Act of 1934 (47

- 1 U.S.C. 336(c)), the Commission shall give priority to ap-
- 2 plicants whose applications undertake a commitment to
- 3 broadcast in a language other than English or which rep-

4 resent traditionally underserved communities.
