## A BILL

To authorize the Secretary of Transportation to convey the National Defense Reserve Fleet vessel S.S. GUAM to American Trade Fair Ship, Inc.

1       *Be it enacted by the Senate and House of Representa-*  
2       *tives of the United States of America in Congress assembled,*

3       **SECTION 1. AUTHORITY TO CONVEY NATIONAL DEFENSE**

4                       **RESERVE FLEET VESSEL S.S. GUAM.**

5       (a) AUTHORITY TO CONVEY.—Notwithstanding any  
6       other law, the Secretary of Transportation (in this section  
7       referred to as the “Secretary”) may convey all right, title,  
8       and interest of the United States Government in and to  
9       the vessel S.S. GUAM (United States official number  
10      LPH 9) to American Trade Fair Ship, Inc. (a not-for-

1 profit corporation established under the laws of the State  
2 of New York; in this section referred to as the “recipient”)  
3 for use by the recipient to exhibit products manufactured  
4 in the United States, during cruises around the World in-  
5 cluding in Europe, South America, and the Far East.

6 (b) TERMS OF CONVEYANCE.—

7 (1) DELIVERY OF VESSEL.—In carrying out  
8 subsection (a), the Secretary shall deliver the  
9 vessel—

10 (A) at the place where the vessel is located  
11 on the date of conveyance;

12 (B) in its condition on that date; and

13 (C) at no cost to the United States Gov-  
14 ernment.

15 (2) REQUIRED CONDITIONS.—The Secretary  
16 may not convey a vessel under this section unless—

17 (A) the recipient agrees to hold the Gov-  
18 ernment harmless for any claims arising from  
19 exposure to hazardous material, including as-  
20 bestos and polychlorinated biphenyls, after con-  
21 veyance of the vessel, except for claims arising  
22 before the date of the conveyance or from use  
23 of the vessel by the Government after that date;  
24 and

1           (B) the recipient has available to restore  
2           the vessel, in the form of cash, liquid assets, or  
3           a written loan commitment, financial resources  
4           of at least \$100,000.

5           (3) ADDITIONAL TERMS.—The Secretary may  
6           require such additional terms in connection with the  
7           conveyance authorized by this section as the Sec-  
8           retary considers appropriate.

9           (c) OTHER UNNEEDED EQUIPMENT.—The Secretary  
10          may convey to the recipient any unneeded equipment from  
11          other vessels in the National Defense Reserve Fleet, for  
12          use to restore the vessel conveyed under this section to  
13          museum quality.
