## A BILL

To amend title 10, United States Code, to direct the Secretary of Defense to establish procedures to allow persons desiring to report an instance of suspected child abuse occurring on a military installation to submit such a report anonymously and to ensure that if such a report is not made anonymously the identity of the person making the report will not be disclosed without written authorization of that person.

1	SECTION 1. SUBMISSION OF ANONYMOUS REPORTS OF
2	SUSPECTED CHILD ABUSE ON MILITARY IN-
3	STALLATIONS
4	(a) In General.—(1) Chapter 80 of title 10, United
5	States Code, is amended by adding at the end the fol-
6	lowing new section:
7	"§ 1563. Reports of suspected child abuse occurring
8	on military installations: anonymity for
9	persons making reports
10	"The Secretary of Defense shall prescribe regulations
11	to ensure that the procedures of the Department of De-
12	fense for receiving reports of suspected child abuse occur-
13	ring on a military installation include provisions to ensure
14	the following:
15	"(1) That such a report can be made, if so de-
16	sired by the person making the report, in a manner
17	(such as a telephone hot-line or other means deter-
18	mined appropriate by the Secretary) that ensures
19	that the identity of the person making the report is
20	not ascertainable by any person receiving the report.
21	"(2) That, in a case in which such a report is
22	made in a manner that permits ascertainment of the
23	identity of the person making the report or of per-
24	sonally identifying information about that person, no
25	person receiving such a report or any other person
26	may disclose, or may record in any manner, any

- 2 the identity of the person making the report without
- 3 the prior authorization in writing of that person.".
- 4 (2) The table of sections at the beginning of such
- 5 chapter is amended by adding at the end the following
- 6 new item:

"1563. Reports of suspected child abuse occurring on military installations: anonymity for persons making reports.".

- 7 (b) Effective Date.—Regulations under section
- 8 1563 of title 10, United States Code, as added by sub-
- 9 section (a), shall be prescribed not later than 180 days
- 10 after the date of the enactment of this Act.
