## A BILL

To amend title XXI of the Social Security Act to prevent conflicts of interest in the use of administrative vendors in the administration of State Children's Health Insurance Plans.

1       *Be it enacted by the Senate and House of Representa-  
2       tives of the United States of America in Congress assembled,*

3 **SECTION 1. SHORT TITLE.**

4       This Act may be cited as the "State Children's  
5       Health Insurance Program Integrity Act of 2000".

1 **SEC. 2. LIMITATION ON USE OF ADMINISTRATIVE VENDORS**2 **IN THE ADMINISTRATION OF STATE CHILDREN'S HEALTH INSURANCE PLANS.**3  
4 (a) IN GENERAL.—Section 2105(c) of the Social Security Act (42 U.S.C. 300aa-5(c)) is amended by adding  
5 at the end the following new paragraph:6  
7 **“(8) LIMITATION ON EXPENDITURES FOR ADMINISTRATIVE VENDORS.**—Amounts expended by a  
8 State for the use of an administrative vendor in  
9 marketing health benefits coverage to low-income  
10 children under this title or in administering other-  
11 wise part or all of the State child health plan under  
12 this title shall be considered, for purposes of sub-  
13 section (a)(2)(D), to be reasonable costs to admin-  
14 ister the plan but only if the following conditions are  
15 met with respect to the vendor:16  
17 “(A) The vendor is independent of any en-  
18 tity offering the coverage and of any health  
19 care providers (whether or not any such pro-  
20 vider participates in the plan under this title)  
21 that provide coverage of services in the same  
22 State in which the vendor is conducting enroll-  
23 ment or administrative activities.24  
25 “(B) No person who is an owner, em-  
26 ployee, consultant, or has a contract with the  
vendor either has any direct or indirect finan-

1           cial interest with such an entity or health care  
2           provider or has been excluded from participa-  
3           tion in the program under this title or title  
4           XVIII or XIX or debarred by any Federal  
5           agency, or subject to a civil money penalty  
6           under this Act.”.

7           (b) EFFECTIVE DATE.—The amendment made by  
8    subsection (a) shall apply to expenditures made on or after  
9    the date of the enactment of this Act.
