A BILL

To provide for the Secretary of Housing and Urban Development to fund, on a 1-year emergency basis, certain requests for grant renewal under the programs for permanent supportive housing and shelter-plus-care for homeless persons.

1 *Be it enacted by the Senate and House of Representa-*
2 *tives of the United States of America in Congress assembled,*

3 **SECTION 1. EMERGENCY FUNDING OF RENEWAL RE-**
4 **QUESTS FOR HOMELESS HOUSING GRANTS.**

5 (a) **AUTHORITY.**—Notwithstanding any other provi-
6 sion of law, from any amounts made available for assist-
7 ance under section 8 of the United States Housing Act

1 of 1937 (42 U.S.C. 1437f) that remain unobligated, the
2 Secretary of Housing and Urban Development shall, for
3 each request described in subsection (b), make a 1-year
4 grant to the entity making the request in the amount
5 under subsection (c).

6 (b) ELIGIBLE RENEWAL REQUESTS.—A request de-
7 scribed in this subsection is a request for a grant under
8 subtitle C of title IV of the Stewart B. McKinney Home-
9 less Assistance Act (42 U.S.C. 11381 et seq.) for perma-
10 nent housing for homeless persons with disabilities or sub-
11 title F of such title (42 U.S.C. 11403 et seq.) that—

12 (1) was submitted in accordance with the eligi-
13 bility requirements established by the Secretary and
14 pursuant to the notice of funding availability for fis-
15 cal year 1999 covering such programs, but was not
16 approved;

17 (2) was made by an entity that received such a
18 grant pursuant to the notice of funding availability
19 for a previous fiscal year; and

20 (3) requested renewal of funding made under
21 such previous grant for use for eligible activities be-
22 cause funding under such previous grant expires
23 during calendar year 2000.

24 (c) GRANT AMOUNT.—The amount under this sub-
25 section is the amount necessary, as determined by the Sec-

1 retary, to renew funding for the eligible activities under
2 the grant request for a period of only 1 year, taking into
3 consideration the amount of funding requested for the
4 first year of funding under the grant request.
