A BILL

To improve character education programs.

- 1 Be it enacted by the Senate and House of Representa-
- 2 tives of the United States of America in Congress assembled,
- 3 SECTION 1. SHORT TITLE.
- 4 This Act may be cited as the "Character Counts for
- 5 the 21st Century Act".
- 6 SEC. 2. CHARACTER EDUCATION PROGRAM.
- 7 Sections 10102 and 10103 of part A of title X of
- 8 the Elementary and Secondary Education Act of 1965 are
- 9 amended to read as follows:

1	"SEC. 10102. STATE AND LOCAL CHARACTER EDUCATION
2	PROGRAM.
3	"(a) Program Authorized.—(1) The Secretary
4	may make grants to State educational agencies, local edu-
5	cational agencies, or consortia of such educational agen-
6	cies for the design and implementation of character edu-
7	cation programs.
8	"(2) Each grant under this section shall be awarded
9	for a period not to exceed five years, of which the recipient
10	shall use not more than one year for planning and pro-
11	gram design.
12	"(b) Applications.—(1) Each applicant desiring a
13	grant under this section shall submit an application to the
14	Secretary at such time and in such manner as the Sec-
15	retary may require.
16	"(2) Each application under this section shall
17	include—
18	"(A) a description of any partnerships and
19	other collaborative efforts between the applicant and
20	other educational agencies;
21	"(B) a description of the program's goals and
22	objectives;
23	"(C) a description of the activities the applicant
24	will carry out, and how these activities are designed
25	to meet the program's goals and objectives under
26	subparagraph (B), including—

1	"(i) how parents, students, and other
2	members of the community, including members
3	of private and nonprofit organizations, will be
4	involved in the design and implementation of
5	the program;
6	"(ii) the curriculum and instructional prac-
7	tices that will be used or developed; and
8	"(iii) the methods of teacher training and
9	parent education that will be used or developed;
10	"(D) a description of how the program will be
11	linked to other efforts to improve educational out-
12	comes, including—
13	"(i) broader educational reforms that are
14	being instituted by the applicant or its partners;
15	and
16	"(ii) applicable State and local standards
17	for student performance;
18	"(E) a description of how the applicant will
19	evaluate the progress of its program in meeting the
20	goals and objectives under subparagraph (B), includ-
21	ing the performance indicators that will be used to
22	measure progress; and
23	"(F) such other information as the Secretary
24	may require.

1	"(c) Diversity of Projects.—The Secretary shall
2	make awards under this section that, to the extent prac-
3	ticable, support programs that serve different geographic
4	areas of the Nation, including urban, suburban, and rural
5	areas.";
6	"SEC. 10103. CHARACTER EDUCATION RESEARCH, DISSEMI-
7	NATION, AND EVALUATION.
8	"(a) Program Authorized.—The Secretary is au-
9	thorized to make grants, or enter into contracts or cooper-
10	ative agreements with, State educational agencies, local
11	educational agencies, institutions of higher education, trib-
12	al organizations, and other public or private agencies or
13	organizations to carry out research, development, dissemi-
14	nation, technical assistance, and evaluation activities that
15	support or inform character education programs under
16	section 10102.
17	"(b) Use of Funds.—Consistent with subsection
18	(a), funds under this section may be used—
19	"(1) to conduct research and development ac-
20	tivities that focus on such matters as—
21	"(A) the effectiveness of instructional mod-
22	els;
23	"(B) materials and curricula that can be
24	used by programs in character education:

1	"(C) models of professional development in
2	character education; and
3	"(D) the development of outcome measures
4	for character education programs;
5	"(2) to provide technical assistance to the agen-
6	cies receiving awards under section 10102, particu-
7	larly on matters of program evaluation;
8	"(3) to conduct a national evaluation of pro-
9	grams under section 10102; and
10	"(4) to compile and disseminate, through var-
11	ious approaches, such as a national clearinghouse—
12	"(A) information on model character edu-
13	cation programs;
14	"(B) character education materials and
15	curricula;
16	"(C) research findings in the area of char-
17	acter education and character development; and
18	"(D) any other information that will be
19	useful to character education program partici-
20	pants and other educators and administrators
21	nationwide.".
