Mr. DICKEY introduced the following bill; which was referred to the
Committee on Ways and Means

A BILL

To provide for the liquidation or reliquidation of certain
entries of carbides.

1 *Be it enacted by the Senate and House of Representa-*
2 *tives of the United States of America in Congress assembled,*

3 **SECTION 1. TREATMENT OF CERTAIN ENTRIES OF CAR-**
4 **BIDES.**

5 (a) IN GENERAL.—Notwithstanding sections 514 and
6 520 of the Tariff Act of 1930 (19 U.S.C. 1514 and 1520)
7 or any other provision of law, upon proper request filed
8 with the United States Custom Service within 180 days
9 after the date of the enactment of this Act, the Customs
10 Service—

1 (1) shall liquidate, or if already liquidated, re-
2 liquidate each entry described in subsection (c) con-
3 taining any merchandise which, at the time of its
4 entry or release from warehouse for consumption,
5 had been classified under subheading 2849.90.50 of
6 the Harmonized Tariff Schedule of the United
7 States;

8 (2) shall assess duties on each entry described
9 in subsection (c) at the special rate of duty under
10 column 1 of the Harmonized Tariff Schedule of the
11 United States regardless of the country of origin of
12 such products; and

13 (3) shall refund all duties on each entry de-
14 scribed in subsection (c) that were paid at the time
15 of original liquidation.

16 (b) PAYMENT AMOUNTS OWED.—Any amounts owed
17 by the United States pursuant to the liquidation or reliqui-
18 dation of any entry under subsection (a) shall be paid
19 within 90 days after the date on which the request for
20 liquidation or reliquidation is made.

21 (c) AFFECTED ENTRIES.—The entries referred to in
22 subsection (a), filed at the Port of Baltimore, are as fol-
