## 4 SAFETY STANDARDS

- 5 SEC. 201. STANDARDS.
- 6 (a) Establishment.—Not later than 6 months after
- 7 the date of the enactment of this Act, the Administrator
- 8 of the United States Fire Administration shall establish
- 9 measurable standards for dormitory fire safety. Such
- 10 standards shall include mandatory fire sprinklers, smoke
- 11 detectors, and open flame resistant furniture and mat-
- 12 tresses.
- 13 (b) Outreach.—The Administrator of the United
- 14 States Fire Administration shall undertake appropriate
- 15 activities to encourage the adoption by State and local au-
- 16 thorities of the standards established under subsection (a).
