## A BILL

To amend the Internal Revenue Code of 1986 to allow all taxpayers a credit against income tax for up to \$200 of charitable contributions.

- 3 SECTION 1. SHORT TITLE.
- 4 This Act may be cited as the "Charitable Giving Act
- 5 of 2000".
- 6 SEC. 2. CREDIT FOR CERTAIN CHARITABLE CONTRIBU-

- 8 (a) General Rule.—Subpart B of part IV of sub-
- 9 chapter A of chapter 1 of the Internal Revenue Code of

2	section:
3	"SEC. 30B. CREDIT FOR CERTAIN CHARITABLE CONTRIBU-
4	TIONS.
5	"(a) General Rule.—There shall be allowed as a
6	credit against the tax imposed by this chapter for the tax-
7	able year an amount equal to the charitable contributions
8	(as defined in section 170(c)) made in cash by taxpayer
9	during the taxable year.
10	"(b) MAXIMUM CREDIT.—The credit allowed by sub-
11	section (a) for any taxable year shall not exceed \$200.
12	"(c) Limitation Based on Liability for Tax.—
13	The credit allowed by subsection (a) for any taxable year
14	shall not exceed the excess (if any) of—
15	"(1) the regular tax for the taxable year re-
16	duced by the sum of the credits allowable under sub-
17	part A and the preceding sections of this subpart,
18	over
19	"(2) the tentative minimum tax for the taxable
20	year.
21	"(d) Special Rules.—
22	"(1) Credit in Lieu of Deduction.—The
23	credit provided by subsection (a) for any charitable
24	contribution shall be in lieu of any deduction other-

- 3 "(2) Election to have section not
- 4 APPLY.—A taxpayer may elect for any taxable year

- 6 (b) CLERICAL AMENDMENT.—The table of sections

- 8 of such Code is amended by adding at the end thereof
- 9 the following new item:

"Sec. 30B. Credit for certain charitable contributions."

- 10 (c) Effective Date.—The amendments made by
- 11 this section shall apply to taxable years beginning after
- 12 December 31, 2000.
