A BILL

- To modify the project for flood control, Yazoo Backwater Area, Yazoo Basin, Mississippi, to authorize the Secretary of the Army to make payments to local interests as compensation for certain reductions in local tax revenues.
 - 1 Be it enacted by the Senate and House of Representa-
 - 2 tives of the United States of America in Congress assembled,
 - 3 SECTION 1. SHORT TITLE.
 - 4 This Act may be cited as the "Yazoo Tax Base Pro-
 - 5 tection Act".

1 SEC. 2. PROJECT MODIFICATION.

- 2 (a) In General.—The project for flood control,
- 3 Yazoo Backwater Area, Yazoo Basin, Mississippi, author-
- 4 ized by section 3 of the Flood Control Act approved Au-
- 5 gust 18, 1941 (55 Stat. 642–643), is modified to author-
- 6 ize the Secretary of the Army to make annual payments,
- 7 during the term of the project, to local interests in the
- 8 project area as compensation for reductions in the ad valo-
- 9 rem tax revenues collected by the local interests that are
- 10 attributable to purchases of reforestation easements by the
- 11 Secretary for the project.
- 12 (b) Amount of Payments.—An annual payment
- 13 made to a local interest in a calendar year under sub-
- 14 section (a) shall equal—
- 15 (1) the amount of ad valorem tax revenues that
- would have been collected by the local interest in the
- 17 calendar year if lands for which the Secretary has
- purchased a reforestation easement for the project
- 19 had the same use that the lands had prior to the
- 20 purchase of the easement; less
- 21 (2) the amount of ad valorem tax revenues col-
- lected by the local interest in the calendar year.
- 23 (c) Definitions.—In this section, the following defi-
- 24 nitions apply:
- 25 (1) Reforestation easement.—The term
- 26 "reforestation easement" means an easement on

- open agricultural land that restricts the future use of the land to woodlands.
- 3 (2) PROJECT AREA.—The term "project area"
 4 means land in the Humphreys, Issaquena, Sharkey,
 5 Warren, Washington, and Yazoo counties, Mississippi, located at or below the 100-year frequency
 7 flood elevation.
