## A BILL

To amend title XVIII of the Social Security Act to require universal product numbers on claims forms submitted for reimbursement for durable medical equipment and other items under the Medicare Program.

- 1 Be it enacted by the Senate and House of Representa-
- 2 tives of the United States of America in Congress assembled,
- 3 SECTION 1. SHORT TITLE.
- 4 This Act may be cited as the "Medicare Universal
- 5 Product Number Act of 1999".

1	SEC. 2. UNIVERSAL PRODUCT NUMBERS FOR CERTAIN
2	ITEMS OF DURABLE MEDICAL EQUIPMENT
3	ON CLAIM FORMS FOR REIMBURSEMENT
4	UNDER THE MEDICARE PROGRAM.
5	(a) In General.—Section 1842 of the Social Secu-
6	rity Act (42 U.S.C. 1395u) is amended by adding at the
7	end the following new subsection:
8	"(u)(1) Each request for payment, or bill submitted,
9	on or after February 1, 2002, for a covered item (as de-
10	fined in paragraph (3)) for which payment may be made
11	under this part shall include a universal product number
12	under the system established by the Secretary under para-
13	graph (4) for such covered item.
14	"(2) No payment may be made under this part on
15	or after February 1, 2002, for a covered item if the re-
16	quest for payment or bill submitted does not include the
17	universal product number of the covered item.
18	"(3)(A) Except as provided in subparagraph (B), for
19	purposes of this subsection, the term 'covered item' means
20	the following items:
21	"(i) A covered item (as defined in section
22	1834(a)(13)).
23	"(ii) An item described in paragraph (8) or (9)
24	of section 1861(s).
25	"(iii) An item described in paragraph (5) of
26	section 1861(s).

- 1 "(iv) Such other items as the Secretary deter-
- 2 mines appropriate.
- 3 "(B) Such term does not include a customized item
- 4 for which payment may be made under this title.
- 5 "(4) The Secretary, in consultation with appropriate
- 6 experts, shall establish a system under which a covered
- 7 item under this subsection is assigned a universal product
- 8 number that permits the Secretary to—
- 9 "(A) identify the covered item;
- 10 "(B) develop appropriate data to adjust rates of
- 11 reimbursement for the covered item as appropriate;
- 12 and
- "(C) review the covered items billed under the
- 14 coding system established under this title and adjust
- such coding system to ensure that functionally
- 16 equivalent covered items are billed and reimbursed
- 17 under the same codes.".
- 18 (b) ACCOMMODATION OF UPNs ON CLAIMS
- 19 Forms.—Not later than February 1, 2001, any claims
- 20 form developed or used by the Secretary of Health and
- 21 Human Services for reimbursement for a covered item (as
- 22 that term is defined in section 1842(u)(3) of the Social
- 23 Security Act, as added by subsection (a)), furnished under
- 24 the medicare program under title XVIII of such Act, shall
- 25 accommodate the use of universal product numbers.

1	(e) Report.—Not later than December 31, 2002,
2	and annually thereafter through 2004, the Secretary of
3	Health and Human Services shall submit to Congress a
4	report that describes—
5	(1) the additional information made available to
6	the Secretary from the use of universal product
7	numbers on covered items furnished under part B of
8	the medicare program (as that term is defined in
9	section 1842(u)(3) of the Social Security Act, as
10	added by subsection (a));
11	(2) any change by the Secretary in reimburse-
12	ment rates for the covered items by reason of such
13	information; and
14	(3) the Secretary's recommendations for addi-
15	tional items reimbursed under the medicare program
16	for which the use of universal product numbers is
17	appropriate.
