A BILL

To authorize appropriations for fiscal year 2001 for certain maritime programs of the Department of Transportation, and for other purposes.

- 1 Be it enacted by the Senate and House of Representa-
- 2 tives of the United States of America in Congress assembled,
- 3 SECTION 1. SHORT TITLE.
- 4 This Act may be cited as the "Maritime Administra-
- 5 tion Authorization Act for Fiscal Year 2001".
- 6 SEC. 2. AUTHORIZATION OF APPROPRIATIONS FOR FISCAL
- 7 YEAR 2001.
- 8 Funds are hereby authorized to be appropriated, as
- 9 appropriations Acts may provide, for the use of the De-

- 1 partment of Transportation for the Maritime Administra-
- 2 tion as follows:
- 3 (1) For expenses necessary for operations and
- 4 training activities, not to exceed \$80,240,000 for the
- 5 fiscal year ending September 30, 2001.
- 6 (2) For the costs, as defined in section 502 of
- 7 the Federal Credit Reform Act of 1990, of guaran-
- 8 teed loans authorized by title XI of the Merchant
- 9 Marine Act, 1936 (46 App. U.S.C. 1271 et seq.),
- \$2,000,000, to be available until expended. In addi-
- tion, for administrative expenses related to loan
- guarantee commitments under title XI of the Mer-
- 13 chant Marine Act, 1936 (46 App. U.S.C. 1271 et
- 14 seq.), \$4,179,000.
- 15 SEC. 3. AMENDMENTS TO TITLE IX OF THE MERCHANT MA-
- 16 RINE ACT, 1936.
- 17 (a) Title IX of the Merchant Marine Act, 1936 (46
- 18 App. U.S.C. 101 et seq.) is amended by adding after sec-
- 19 tion 902 the following:
- 20 "SEC. 903. DOCUMENTATION OF CERTAIN DRY CARGO VES-
- 21 **SELS.**
- "The restrictions of section 901(b)(1) of this Act con-
- 23 cerning a vessel built in a foreign country shall not apply
- 24 to a drybulk or breakbulk vessel over 7,500 deadweight
- 25 tons that has been delivered from a foreign shipyard or

- 1 contracted for construction in a foreign shipyard within
- 2 either 1 year of the date of enactment of this section, or,
- 3 no later than the effective date of the OECD Shipbuilding
- 4 Trade Agreement Act, whichever occurs earlier. A vessel
- 5 timely contracted for or delivered pursuant to this section
- 6 and documented under the laws of the United States shall
- 7 be deemed to have been United States built for purposes
- 8 of sections 901(b) and 901b of this Act: Provided, That
- 9 (1) following delivery by a foreign shippard, the vessel
- 10 shall have any additional shipyard work necessary to re-
- 11 ceive a Coast Guard certificate of inspection performed in
- 12 a United States shipyard; (2) the vessel is not documented
- 13 in another country before being documented under the
- 14 laws of the United States; (3) the vessel complies with the
- 15 same inspection standards set forth for ocean common
- 16 carriers in section 1137 of the Coast Guard Authorization
- 17 Act of 1996 (46 App. U.S.C. 1187 note); (4) actual deliv-
- 18 ery of a vessel contracted for construction takes place on
- 19 or before the 3-year anniversary of the date of the contract
- 20 to construct the vessel; and (5) the provisions of section
- 21 9(e) of the Shipping Act, 1916, as amended on October
- 22 19, 1996, shall not apply to a vessel built pursuant to this
- 23 section.".
- 24 (b) Section 901b(c)(2) of the Merchant Marine Act,
- 25 1936 (46 U.S.C. App. 1241f(c)(2)) is amended by striking

- 1 "1986." and inserting "1986, the 18-month period com-
- 2 mencing April 1, 2000, and the 12-month period begin-
- 3 ning on the first day of October in the year 2001 and
- 4 each year thereafter.".
- 5 SEC. 4. AMENDMENT RELATING TO DISPOSAL OF OBSO-
- 6 LETE VESSELS FROM THE NATIONAL DE-
- 7 FENSE RESERVE FLEET.
- 8 Section 6(c)(1)(A) of the National Maritime Heritage
- 9 Act of 1994 (Public Law 103-451; 108 Stat. 4776; 16
- 10 U.S.C. 5405) is amended by striking out "2001" and in-
- 11 serting in lieu thereof "2006".
