- 1 Be it enacted by the Senate and House of Representa-
- 2 tives of the United States of America in Congress assembled,
- 3 SECTION 1. SHORT TITLE.
- 4 This Act may be cited as the "Veterans' Higher Edu-
- 5 cation Opportunities Act of 2000".

1	SEC. 2. ANNUAL DETERMINATION OF BASIC BENEFIT OF
2	ACTIVE DUTY EDUCATIONAL ASSISTANCE
3	UNDER THE MONTGOMERY GI BILL.
4	(a) Basic Benefit.—Section 3015 of title 38,
5	United States Code, is amended—
6	(1) in subsection (a)(1), by striking "of \$528
7	(as increased from time to time under subsection
8	(g))" and inserting "equal to the average monthly
9	costs of tuition and expenses for commuter students
10	at public institutions of higher education that award
11	baccalaureate degrees (as determined under sub-
12	section (g))"; and
13	(2) in subsection (b)(1) by striking "of $$429$
14	(as increased from time to time under subsection
15	(g))" and inserting "equal to 75 percent of the aver-
16	age monthly costs of tuition and expenses for com-
17	muter students at public institutions of higher edu-
18	cation that award baccalaureate degrees (as deter-
19	mined under subsection (g))".
20	(b) Determination of Average Monthly
21	Costs.—Subsection (g) of that section is amended to read
22	as follows:
23	"(g)(1) Not later than September 30 each year, the
24	Secretary shall determine the average monthly costs of tui-
25	tion and expenses for commuter students at public institu-
26	tions of higher education that award baccalaureate de-

- 2 succeeding fiscal year. The Secretary shall determine such
- 3 costs utilizing information obtained from the College
- 4 Board or information provided annually by the College

- 7 "(2) In determining the costs of tuition and expenses
- 8 under paragraph (1), the Secretary shall take into account
- 9 the following:
- 10 "(A) Tuition and fees.
- 11 "(B) The cost of books and supplies.
- "(C) The cost of board.
- 13 "(D) Transportation costs.
- 14 "(E) Other nonfixed educational expenses.
- 15 "(3) A determination made under paragraph (1) in
- 16 a year shall take effect on October 1 of that year and
- 17 apply with respect to basic educational assistance allow-
- 18 ances payable under this section for the fiscal year begin-
- 19 ning in that year.
- 20 "(4) Not later than September 30 each year, the Sec-
- 21 retary shall publish in the Federal Register the average
- 22 monthly costs of tuition and expenses as determined under
- 23 paragraph (1) in that year.
- 24 "(5) For purposes of this section, the term 'institu-
- 25 tion of higher education' has the meaning given that term

- 1 in section 101 of the Higher Education Act of 1965 (20
- 2 U.S.C. 1001).".
- 3 (c) STYLISTIC AMENDMENT.—Subsection (b) of that
- 4 section is further amended in the matter preceding para-
- 5 graph (1) by striking "as provided in the succeeding sub-
- 6 sections of this section" and inserting "as otherwise pro-
