A BILL

To allow postal patrons to contribute to funding for AIDS research and education through the voluntary purchase of certain specially issued United States postage stamps.

- 1 Be it enacted by the Senate and House of Representa-
- 2 tives of the United States of America in Congress assembled,
- 3 SECTION 1. SHORT TITLE.
- 4 This Act may be cited as the "Faces of AIDS Stamp
- 5 Act of 1999".
