## A BILL

To amend title XIX of the Social Security Act to permit the Secretary of Health and Human Services to waive recoupment of Federal Government Medicaid claims to tobacco-related State settlements if the State uses the funds only for programs to reduce smoking and for public health purposes.

- 1 Be it enacted by the Senate and House of Representa-
- 2 tives of the United States of America in Congress assembled,

1	SECTION 1. PERMITTING WAIVER OF RECOUPMENT OF
2	MEDICAID TOBACCO-RELATED RECOVERIES
3	IF RECOVERIES USED TO REDUCE SMOKING
4	AND FOR PUBLIC HEALTH PURPOSES.
5	(a) In General.—Section 1903(d)(3) of the Social
6	Security Act (42 U.S.C. 1396b(d)(3)) is amended—
7	(1) by inserting "(A)" before "The"; and
8	(2) by adding at the end the following:
9	"(B) Subparagraph (A) and paragraph (2)(B) shall
10	not apply to any amount recovered or paid to a State as
11	part of a settlement or judgment reached in litigation initi-
12	ated or pursued by a State against one or more manufac-
13	turers of tobacco products, as defined in section 5702(d)
14	of the Internal Revenue Code of 1986, if (and to the ex-
15	tent that) the Secretary finds that following conditions are
16	met:
17	"(i) The State has filed with the Secretary a
18	plan which specifically outlines how the Federal
19	share of the amounts so recovered will be spent con-
20	sistent with the following:
21	"(I) At least 40 percent of such amounts,
22	recovered in any fiscal year, will be spent on ef-
23	forts to reduce smoking using methods that
24	have been shown to be effective, such as smok-
25	ing cessation programs, anti-smoking enforce-
26	ment activities, community-based anti-smoking

1	programs, and school-based education pro-
2	grams.
3	"(II) Such amounts not spent for the pur-
4	poses described in subclause (I) will be spent
5	only on essential public health services, includ-
6	ing (but not limited to) the public health activi-
7	ties described in subparagraph (C).
8	"(III) All such amounts will be spent only
9	in a manner that supplements (and does not
10	supplant) funds previously being spent by the
11	State (or local governments in the State) for
12	such or similar programs or activities.
13	"(ii) Before the beginning of each fiscal year,
14	the State files with the Secretary a report which de-
15	tails how the Federal share of the amounts so recov-
16	ered have been spent consistent with the plan de-
17	scribed in clause (i).
18	"(C) The public health activities described in this
19	subparagraph are as follows:
20	"(i) Monitoring health status to identify com-
21	munity health problems.
22	"(ii) Diagnosing and investigating health prob-
23	lems and health hazards in the community.
24	"(iii) Enforcing laws and regulations that pro-
25	tect public health.

1	"(iv) Informing, educating, and empowering
2	people about health issues.
3	"(v) Mobilizing community partnerships to
4	identify and solve health problems.
5	"(vi) Linking people to needed personal health
6	services and assuring the provision of health care
7	when otherwise unavailable.
8	"(vii) Evaluating effectiveness, accessibility, and
9	quality of personal and population-based health serv-
10	ices.
11	"(viii) Assuring a competent public health and
12	personal health care workforce.
13	"(ix) Developing policies and plans that support
14	individual and community health efforts.
15	"(x) Conducting research for new insights and
16	innovative solutions to health problems.
17	"(D) If the Secretary determines that amounts de-
18	scribed in subparagraph (B) are not being spent in accord-
19	ance with the plan described in (and that meets the re-
20	quirements of) subparagraph (B)(i), subparagraph (A)
21	and paragraph (2)(B) shall apply to such amounts and
22	the Secretary shall take appropriate action to offset such
23	amounts from the amounts otherwise paid to the State
24	under this title.

- 1 "(E) Amounts equivalent to the reductions in pay-
- 2 ments under this title which are attributable to recoveries
- 3 described in subparagraph (B) which are not recouped or
- 4 offset because of such subparagraph shall be deposited by
- 5 the Secretary into a separate fund in the Treasury which
- 6 shall be used and available to the Secretary, without fur-
- 7 ther appropriation, to carry out Federal grant-in-aid pro-
- 8 grams to reduce tobacco use among minors.".
- 9 (b) Effective Date.—The amendments made by
- 10 subsection (a) apply to amounts recovered or paid to a
- 11 State before, on, or after the date of enactment of this
- 12 Act.
