Mr. BARR of Georgia introduced the following bill; which was referred to the Committee on International Relations

## A BILL

To prohibit the use of funds to administer or enforce the provisions of Executive Order 13107, relating to the implementation of certain human rights treaties.

1       *Be it enacted by the Senate and House of Representa-*  
2       *tives of the United States of America in Congress assembled,*

3       **SECTION 1. SHORT TITLE.**

4       This Act may be cited as the “United States Federal  
5       Government Preservation Act of 1999”.

6       **SEC. 2. FINDINGS.**

7       Congress finds the following:

8               (1) Article II, section 2, clause 2 of the Con-  
9       stitution of the United States provides that “He [the

1 President] shall have Power, by and with the Advice  
2 and Consent of the Senate, to make Treaties, pro-  
3 vided two thirds of the Senators present concur;”.

4 (2) The International Covenant on Civil and  
5 Political Rights (ICCPR), the Convention Against  
6 Torture and Other Cruel, Inhuman or Degrading  
7 Treatment or Punishment (CAT), the Convention on  
8 the Elimination of All Forms of Racial Discrimina-  
9 tion (CERD), and other relevant treaties concerned  
10 with the protection and promotion of human rights  
11 are treaties with respect to which the Senate has  
12 given its advice and consent to ratification, however,  
13 the votes for such advice and consent to ratification  
14 were not formal roll call votes but instead voice votes  
15 which do not provide a record as to how each indi-  
16 vidual Senator voted on each of these treaties.

17 (3) On December 10, 1998, President Clinton  
18 issued Executive Order 13107 (63 Fed. Reg. 68991  
19 (December 15, 1998)) which states in part “[i]t  
20 shall be the policy and practice of the Government  
21 of the United States, being committed to the protec-  
22 tion and promotion of human rights and fundamen-  
23 tal freedoms, fully to respect and implement its obli-  
24 gations under international human rights treaties to

1       which it is a party, including the ICCPR, the CAT,  
2       and the CERD.”.

3           (4) Executive Order 13107 also states that  
4       “[a]ll executive departments and agencies . . . shall  
5       maintain a current awareness of United States inter-  
6       national human rights obligations that are relevant  
7       to their functions and shall perform such functions  
8       so as to respect and implement those obligations  
9       fully. The head of each agency shall designate a sin-  
10      gle contact officer who will be responsible for overall  
11      coordination of the implementation of this order.”.

12          (5) Executive Order 13107 also establishes an  
13      Interagency Working Group in Human Rights Trea-  
14      ties for the “purpose of providing guidance, over-  
15      sight, and coordination with respect to questions  
16      concerning the adherence to and implementation of  
17      human rights obligations and related matters.”.

18   **SEC. 3. PROHIBITION ON USE OF FUNDS TO ADMINISTER**  
19                   **OR ENFORCE EXECUTIVE ORDER 13107.**

20      None of the funds appropriated in any Act for any  
21      fiscal year may be used to administer or enforce the provi-  
22      sions of Executive Order 13107 (63 Fed. Reg. 68991 (De-  
23      cember 15, 1998); relating to the implementation of cer-  
24      tain human rights treaties).
