AN ACT

To amend title 38, United States Code, to enact into law eligibility requirements for burial in Arlington National Cemetery, and for other purposes.

- 1 Be it enacted by the Senate and House of Representa-
- 2 tives of the United States of America in Congress assembled,

1	SECTION 1. SHORT TITLE.
2	This Act may be cited as the "Arlington National
3	Cemetery Burial Eligibility Act".
4	SEC. 2. PERSONS ELIGIBLE FOR BURIAL IN ARLINGTON NA-
5	TIONAL CEMETERY.
6	(a) In General.—Chapter 24 of title 38, United
7	States Code, is amended by adding at the end the fol-
8	lowing new section:
9	"§ 2412. Arlington National Cemetery: persons eligi-
10	ble for burial
11	"(a) Primary Eligibility.—The remains of the fol-
12	lowing individuals may be buried in Arlington National
13	Cemetery:
14	"(1) Any member of the Armed Forces who
15	dies while on active duty.
16	"(2) Any retired member of the Armed Forces
17	and any person who served on active duty and at the
18	time of death was entitled (or but for age would
19	have been entitled) to retired pay under chapter
20	1223 of title 10, United States Code.
21	"(3) Any former member of the Armed Forces
22	separated for physical disability before October 1,
23	1949, who—
24	"(A) served on active duty; and
25	"(B) would have been eligible for retire-

ment under the provisions of section 1201 of

1	title 10 (relating to retirement for disability)
2	had that section been in effect on the date of
3	separation of the member.
4	"(4) Any former member of the Armed Forces
5	whose last active duty military service terminated
6	honorably and who has been awarded one of the fol-
7	lowing decorations:
8	"(A) Medal of Honor.
9	"(B) Distinguished Service Cross, Air
10	Force Cross, or Navy Cross.
11	"(C) Distinguished Service Medal.
12	"(D) Silver Star.
13	"(E) Purple Heart.
14	"(5) Any former prisoner of war who dies on or
15	after November 30, 1993.
16	"(6) The President or any former President.
17	"(b) Eligibility of Family Members.—The re-
18	mains of the following individuals may be buried in Arling-
19	ton National Cemetery:
20	"(1) The spouse, surviving spouse (which for
21	purposes of this paragraph includes any remarried
22	surviving spouse, section 2402(5) of this title not-
23	withstanding), minor child, and, at the discretion of
24	the Superintendent, unmarried adult child of a per-

- son listed in subsection (a), but only if buried in the same gravesite as that person.
 - "(2)(A) The spouse, minor child, and, at the discretion of the Superintendent, unmarried adult child of a member of the Armed Forces on active duty if such spouse, minor child, or unmarried adult child dies while such member is on active duty.
 - "(B) The individual whose spouse, minor child, and unmarried adult child is eligible under subparagraph (A), but only if buried in the same gravesite as the spouse, minor child, or unmarried adult child.
 - "(3) The parents of a minor child or unmarried adult child whose remains, based on the eligibility of a parent, are already buried in Arlington National Cemetery, but only if buried in the same gravesite as that minor child or unmarried adult child.
 - "(4)(A) Subject to subparagraph (B), the surviving spouse, minor child, and, at the discretion of the Superintendent, unmarried adult child of a member of the Armed Forces who was lost, buried at sea, or officially determined to be permanently absent in a status of missing or missing in action.
 - "(B) A person is not eligible under subparagraph (A) if a memorial to honor the memory of the member is placed in a cemetery in the national cem-

- 1 etery system, unless the memorial is removed. A me-
- 2 morial removed under this subparagraph may be
- 3 placed, at the discretion of the Superintendent, in
- 4 Arlington National Cemetery.
- 5 "(5) The surviving spouse, minor child, and, at
- 6 the discretion of the Superintendent, unmarried
- 7 adult child of a member of the Armed Forces buried
- 8 in a cemetery under the jurisdiction of the American
- 9 Battle Monuments Commission.
- 10 "(c) Disabled Adult Unmarried Children.—In
- 11 the case of an unmarried adult child who is incapable of
- 12 self-support up to the time of death because of a physical
- 13 or mental condition, the child may be buried under sub-
- 14 section (b) without requirement for approval by the Super-
- 15 intendent under that subsection if the burial is in the same
- 16 gravesite as the gravesite in which the parent, who is eligi-
- 17 ble for burial under subsection (a), has been or will be
- 18 buried.
- 19 "(d) Family Members of Persons Buried in a
- 20 Group Gravesite.—In the case of a person eligible for
- 21 burial under subsection (a) who is buried in Arlington Na-
- 22 tional Cemetery as part of a group burial, the surviving
- 23 spouse, minor child, or unmarried adult child of the mem-
- 24 ber may not be buried in the group gravesite.

1	"(e) Exclusive Authority for Burial in Ar-
2	LINGTON NATIONAL CEMETERY.—Eligibility for burial of
3	remains in Arlington National Cemetery prescribed under
4	this section is the exclusive eligibility for such burial.
5	"(f) APPLICATION FOR BURIAL.—A request for bur-
6	ial of remains of an individual in Arlington National Cem-
7	etery made before the death of the individual may not be
8	considered by the Secretary of the Army or any other re-
9	sponsible official.
10	"(g) Register of Buried Individuals.—(1) The
11	Secretary of the Army shall maintain a register of each
12	individual buried in Arlington National Cemetery and
13	shall make such register available to the public.
14	"(2) With respect to each such individual buried on
15	or after January 1, 1998, the register shall include a brief
16	description of the basis of eligibility of the individual for
17	burial in Arlington National Cemetery.
18	"(h) Definitions.—For purposes of this section:
19	"(1) The term 'retired member of the Armed
20	Forces' means—
21	"(A) any member of the Armed Forces on
22	a retired list who served on active duty and who
23	is entitled to retired pay;
24	"(B) any member of the Fleet Reserve or
25	Fleet Marine Corps Reserve who served on ac-

- tive duty and who is entitled to retainer pay;
 and
- "(C) any member of a reserve component of the Armed Forces who has served on active duty and who has received notice from the Secretary concerned under section 12731(d) of title 10, of eligibility for retired pay under chapter 1223 of title 10, United States Code.
- 9 "(2) The term 'former member of the Armed 10 Forces' includes a person whose service is considered 11 active duty service pursuant to a determination of 12 the Secretary of Defense under section 401 of Public 13 Law 95–202 (38 U.S.C. 106 note).
- 14 "(3) The term 'Superintendent' means the Su-15 perintendent of Arlington National Cemetery.".
- 16 (b) Publication of Updated Pamphlet.—Not 17 later than 180 days after the date of the enactment of 18 this Act, the Secretary of the Army shall publish an up-19 dated pamphlet describing eligibility for burial in Arling-

- 7 (2) Section 2402(7) of such title is amended—
- 8 (A) by inserting "(or but for age would have
- 9 been entitled)" after "was entitled";
- 10 (B) by striking out "chapter 67" and inserting
- in lieu thereof "chapter 1223"; and
- 12 (C) by striking out "or would have been entitled
- to" and all that follows and inserting in lieu thereof
- a period.
- 15 (e) Effective Date.—(1) Except as provided in
- 16 paragraph (2), section 2412 of title 38, United States
- 17 Code, as added by subsection (a), shall apply with respect
- 18 to individuals dying on or after the date of the enactment
- 19 of this Act.
- 20 (2) In the case of an individual buried in Arlington
- 21 National Cemetery before the date of the enactment of
- 22 this Act, the surviving spouse of such individual is deemed
- 23 to be eligible for burial in Arlington National Cemetery
- 24 under subsection (b) of such section, but only in the same
- 25 gravesite as such individual.

1	SEC. 3. PERSONS ELIGIBLE FOR PLACEMENT IN THE COL-
2	UMBARIUM IN ARLINGTON NATIONAL CEME-
3	TERY.
4	(a) In General.—Chapter 24 of title 38, United
5	States Code, is amended by adding after section 2412, as
6	added by section 2(a) of this Act, the following new sec-
7	tion:
8	"§ 2413. Arlington National Cemetery: persons eligi-
9	ble for placement in columbarium
10	"The cremated remains of the following individuals
11	may be placed in the columbarium in Arlington National
12	Cemetery:
13	"(1) A person eligible for burial in Arlington
14	National Cemetery under section 2412 of this title.
15	"(2)(A) A veteran whose last period of active
16	duty service (other than active duty for training)
17	ended honorably.
18	"(B) The spouse, surviving spouse, minor child,
19	and, at the discretion of the Superintendent of Ar-
20	lington National Cemetery, unmarried adult child of
21	such a veteran.".
22	(b) Clerical Amendment.—The table of sections
23	at the beginning of chapter 24 of title 38, United States
24	Code, is amended by adding after section 2412, as added
25	by section 2(c) of this Act, the following new item:

"2413. Arlington National Cemetery: persons eligible for placement in columbarium.".

- 2 11201(a)(1) of title 46, United States Code, is amended
- 3 by inserting after subparagraph (B), the following new
- 4 subparagraph:
- 5 "(C) Section 2413 (relating to placement

- 8 (d) Effective Date.—Section 2413 of title 38,
- 9 United States Code, as added by subsection (a), and sec-
- 10 tion 11201(a)(1)(C), as added by subsection (c), shall
- 11 apply with respect to individuals dying on or after the date
- 12 of the enactment of this Act.
- 13 SEC. 4. MONUMENTS IN ARLINGTON NATIONAL CEMETERY.
- 14 (a) IN GENERAL.—Chapter 24 of title 38, United
- 15 States Code, is amended by adding after section 2413, as
- 16 added by section 3(a) of this Act, the following new
- 17 section:
- 18 "§ 2414. Arlington National Cemetery: authorized
- 19 headstones, markers, and monuments
- 20 "(a) Gravesite Markers Provided by the Sec-
- 21 RETARY.—A gravesite in Arlington National Cemetery
- 22 shall be appropriately marked in accordance with section
- 23 2404 of this title.

1	"(b) Gravesite Markers Provided at Private
2	EXPENSE.—(1) The Secretary of the Army shall prescribe
3	regulations for the provision of headstones or markers to
4	mark a gravesite at private expense in lieu of headstones
5	and markers provided by the Secretary of Veterans Affairs
6	in Arlington National Cemetery.
7	"(2) Such regulations shall ensure that—
8	"(A) such headstones or markers are of simple
9	design, dignified, and appropriate to a military cem-
10	etery;
11	"(B) the person providing such headstone or
12	marker provides for the future maintenance of the
13	headstone or marker in the event repairs are nec-
14	essary;
15	"(C) the Secretary of the Army shall not be lia-
16	ble for maintenance of or damage to the headstone
17	or marker;
18	"(D) such headstones or markers are aestheti-
19	cally compatible with Arlington National Cemetery
20	and
21	"(E) such headstones or markers are permitted
22	only in sections of Arlington National Cemetery au-
23	thorized for such headstones or markers as of Janu-
24	om; 1 1047

- 1 "(c) Monuments.—(1) No monument (or similar
- 2 structure as determined by the Secretary of the Army in
- 3 regulations) may be placed in Arlington National Ceme-
- 4 tery except pursuant to the provisions of this subsection.
- 5 "(2) A monument may be placed in Arlington Na-
- 6 tional Cemetery if the monument commemorates—
- 7 "(A) the service in the Armed Forces of the in-
- 8 dividual, or group of individuals, whose memory is to
- 9 be honored by the monument; or
- 10 "(B) a particular military event.
- 11 "(3) No monument may be placed in Arlington Na-
- 12 tional Cemetery until the end of the 25-year period
- 13 beginning—
- 14 "(A) in the case of commemoration of service
- under paragraph (1)(A), on the last day of the pe-
- riod of service so commemorated; and
- 17 "(B) in the case of commemoration of a par-
- ticular military event under paragraph (1)(B), on
- the last day of the period of the event.
- 20 "(4) A monument may be placed only in those sec-
- 21 tions of Arlington National Cemetery designated by the
- 22 Secretary of the Army for such placement.".
- 23 (b) Clerical Amendment.—The table of sections
- 24 at the beginning of chapter 24 of title 38, United States

- 1 Code, is amended by adding after section 2413, as added
- 2 by section 3(b) of this Act, the following new item:
 - "2414. Arlington National Cemetery: authorized headstones, markers, and monuments.".
- 3 (c) Effective Date.—The amendment made by
- 4 subsection (a) shall apply with respect to headstones,
- 5 markers, or monuments placed in Arlington National
- 6 Cemetery on or after the date of the enactment of this
- 7 Act.
- 8 SEC. 5. PUBLICATION OF REGULATIONS.
- 9 Not later than one year after the date of the enact-
- 10 ment of this Act, the Secretary of the Army shall publish
- 11 in the Federal Register any regulation proposed by the
- 12 Secretary under this Act.
