A BILL

To improve consumers' access to airline industry information, to promote competition in the aviation industry, and for other purposes.

- 1 Be it enacted by the Senate and House of Representa-
- 2 tives of the United States of America in Congress assembled,
- 3 SECTION 1. SHORT TITLE.
- 4 This Act may be cited as the "Aviation Consumer
- 5 Right To Know Act of 1999".
- 6 SEC. 2. AIRLINE PASSENGER PROTECTION.
- 7 (a) In General.—Subchapter I of chapter 417 of
- 8 title 49, United States Code, is amended by adding at the
- 9 end the following:

1 "§ 41716. Air carrier passenger protection

- 2 "(a) Code Sharing.—No air carrier, foreign air car-
- 3 rier, or ticket agent may sell air transportation in the
- 4 United States for a flight that bears a designator code
- 5 of a carrier other than the carrier that will provide the
- 6 air transportation unless the air carrier, foreign air car-
- 7 rier, or ticket agent selling the air transportation first in-
- 8 forms the person purchasing the air transportation that
- 9 the carrier providing the air transportation will be a car-
- 10 rier other than the carrier whose designator code is used
- 11 to identify the flight and informs the person of the cor-
- 12 porate name of the other carrier.
- 13 "(b) Frequent Flyer Awards.—Upon request of
- 14 any person (including a governmental entity), an air car-
- 15 rier shall disclose the number or percentage of seats that
- 16 the carrier intends to make available on a specific date
- 17 for use by a person redeeming an award under a frequent
- 18 flyer program of the carrier on any route in air transpor-
- 19 tation provided by the carrier.
- 20 "(c) Access to Airfare Information.—Upon re-
- 21 quest of any person (including a governmental entity), an
- 22 air carrier shall—
- 23 "(1) provide the person full access to all fares
- for air transportation provided by the air carrier, re-
- 25 gardless of the technology the person uses to access
- the fares; and

1	"(2) permit the person to purchase air trans-
2	portation provided by the air carrier at any pub-
3	lished fare.
4	"(d) Air Carrier Pricing Policies.—An air car-
5	rier may not—
6	"(1) prohibit a person (including a govern-
7	mental entity) that purchases air transportation
8	from only using a portion of the air transportation
9	purchased (including using the air transportation
10	purchased only for 1-way travel instead of round-trip
11	travel); and
12	"(2) assess an additional fee on or charge to—
13	"(A) such a person; or
14	"(B) any ticket agent that sold the air
15	transportation to such person.
16	"(e) Delay, Cancellation, or Diversion.—
17	"(1) Explanation required.—An announce-
18	ment by an air carrier of (A) a delay or cancellation
19	of a flight, (B) a diversion of a flight to an airport
20	other than the airport at which the flight is sched-
21	uled to land, or (C) a delay in deplaning following
22	the touchdown of an aircraft at an airport shall in-
23	clude an explanation of the reason or reasons for the
24	delay, cancellation, or diversion and, in the case of
25	a delay, the expected length of the delay.

1	"(2) Prohibition on false or misleading
2	EXPLANATIONS.—No air carrier shall provide an ex-
3	planation under paragraph (1) that the air carrier
4	knows or has reason to know is false or misleading.
5	"(f) Use of Insecticides.—No air carrier, foreign
6	air carrier, or ticket agent may sell air transportation in
7	the United States for a flight on which an insecticide is
8	planned to be used in the aircraft while passengers are
9	on board the aircraft unless the air carrier, foreign air
10	carrier, or ticket agent selling the air transportation first
11	informs the person purchasing the air transportation of
12	the planned use of the insecticide, including the name of
13	the insecticide.".
14	(b) Conforming Amendment.—The table of sec-
15	tions for such title is amended by inserting after the item
16	relating to section 41715 the following:

"41716. Air carrier passenger protection.".
