1	SECTION 1. RESTORATION OF NONAPPLICABILITY OF PRI-
2	VATE CONTRACTS FOR THE PROVISION OF
3	MEDICARE BENEFITS.
4	(a) In General.—Section 1802 of the Social Secu-
5	rity Act (42 U.S.C. 1395a(b)) is amended by striking sub-
6	section (b), as added by section 4507(a) of the Balanced
7	Budget Act of 1997, and inserting the following new sub-
8	section:
9	"(b) Prohibition on Private Contracts.—A pro-
10	vision of any contract, agreement, or other arrangement
11	that provides for waiver of the claims submission require-
12	ment under paragraph (4) of section 1848(g), for the
13	waiver of the billing limitation described in paragraphs (1)
14	and (2) of such section, or for both, is invalid and not
15	enforceable.".
16	(b) Conforming Amendments.—
17	(1) Section 1862(a) of the Social Security Act
18	(42 U.S.C. 1395y(a)) is amended—
19	(A) by striking paragraph (19); and
20	(B) by redesignating paragraphs (20) and
21	(21) as paragraphs (19) and (20), respectively.

25	(e) Effective Date.—The amendments made by
