## AN ACT

To convey the Sly Park Dam and Reservoir to the El Dorado Irrigation District, and for other purposes.

- 1 Be it enacted by the Senate and House of Representa-
- 2 tives of the United States of America in Congress assembled,
- 3 SECTION 1. DEFINITIONS.
- 4 For the purpose of this Act, the term—
- 5 (1) "Secretary" means the Secretary of the In-
- 6 terior;

- 1 (2) "Sly Park Unit" means the Sly Park Dam
- and Reservoir, Camp Creek Diversion Dam and
- 3 Tunnel, and conduits and canals as authorized
- 4 under the American River Act of October 14, 1949
- 5 (63 Stat. 853), including those used to convey, treat,
- 6 and store water delivered from Sly Park, as well as
- 7 all recreation facilities thereto; and
- 8 (3) "District" means the El Dorado Irrigation
- 9 District.

#### 10 SEC. 2. TRANSFER OF SLY PARK UNIT.

- 11 (a) IN GENERAL.—The Secretary shall, as soon as
- 12 practicable after date of the enactment of this Act and
- 13 in accordance with all applicable law, transfer all right,
- 14 title, and interest in and to the Sly Park Unit to the Dis-
- 15 trict.
- 16 (b) Sale Price.—The Secretary is authorized to re-
- 17 ceive from the District \$2,000,000 to relieve payment obli-
- 18 gations and extinguish the debt under contract number
- 19 <del>14-06-200-949IR2,</del> 14-06-200-949IR3, and \$9,500,000
- 20 to relieve payment obligations and extinguish all debts as-
- 21 sociated with contracts numbered 14-06-200-7734, as
- 22 amended by contracts numbered 14-06-200-4282A and
- 23 14-06-200-8536A. Notwithstanding the preceding sen-
- 24 tence, the District shall continue to make payments re-

- 1 quired by section 3407(c) of Public Law 102–575 through
- 2 year 2029.
- 3 (c) Credit Revenue to Project Repayment.—
- 4 Upon payment authorized under subsection (b), the
- 5 amount paid shall be credited toward repayment of capital
- 6 costs of the Central Valley Project in an amount equal
- 7 to the associated undiscounted obligation.

#### 8 SEC. 3. FUTURE BENEFITS.

- 9 Upon payment, the Sly Park Unit shall no longer be
- 10 a Federal reclamation project or a unit of the Central Val-
- 11 ley Project, and the District shall not be entitled to receive
- 12 any further reclamation benefits.

#### 13 SEC. 4. LIABILITY.

- Except as otherwise provided by law, effective on the
- 15 date of conveyance of the Sly Park Unit under this Act,
- 16 the United States shall not be liable for damages of any
- 17 kind arising out of any act, omission, or occurrence based
- 18 on its prior ownership or operation of the conveyed prop-
- 19 erty.

#### 20 **SEC. 5. COSTS.**

- 21 All costs, including interest charges, associated with
- 22 the Project that have been included as a reimbursable cost

- 1 of the Central Valley Project are declared to be non-
- 2 reimbursable and nonreturnable.
