RESOLUTION

- Recognizing the significance to society of issues relating to mental illness and expressing full support for the White House Conference on Mental Health.
- Whereas in June 1999 the White House will hold the White House Conference on Mental Health;
- Whereas the conference is the result of the work of Mrs. Tipper Gore, the mental health policy advisor to the President;
- Whereas Mrs. Gore has devoted much of her life to raising awareness of issues related to mental health and has both an informed understanding of the issues to be explored at the conference and an appreciation of the complexities of the issues;
- Whereas mental illnesses are a variety of different disorders of the brain, many of which often result in challenges in coping with the ordinary demands of life;
- Whereas persons with mental illnesses often need a continuum of care that may include job training, child care, substance abuse treatment, and mental health services;
- Whereas States, communities, providers, and insurance agencies have ethical obligations to provide humane and effective treatment to persons with mental illnesses who are in correctional settings;
- Whereas approximately 10,000,000 adults in the United States suffer serious and chronic effects from mental illness, and 3,500,000 to 4,000,000 children suffer from emotional disturbance;
- Whereas mental illnesses can affect persons of any gender, age, race, ethnicity, religion, or income;

- Whereas mental illnesses are highly treatable for people of all ages;
- Whereas issues relating to mental illness have failed to receive national attention at levels that are commensurate with their significance to society;
- Whereas stigmas associated with mental illness are detrimental to receiving appropriate diagnosis, treatment, and care for persons with mental illnesses;
- Whereas persons with mental illnesses experience discriminatory practices in access to availability of appropriate care;
- Whereas the conference will bring together mental health providers, consumers, State officials and other public officials, and representatives of private-sector entities and foundations to develop strategies for eliminating the stigmas relating to mental illness and for encouraging a healthy environment where persons with mental illnesses can receive the diagnosis, treatment, and care that they need; and
- Whereas the conference will highlight promising methods to reduce discrimination and improve prevention and treatment, and will explore new actions that public agencies and private entities can take to improve the lives of persons with mental illnesses: Now, therefore, be it
