RESOLUTION

1 *Resolved*, That rule XXI of the Rules of the House
2 of Representatives is amended by adding at the end the
3 following:

4 **“Designations of buildings, highways, and other**
5 **structures**

6 “5. It shall not be in order to consider a bill, joint
7 resolution, amendment, or conference report that provides
8 for the designation or redesignation of any building, high-
9 way, or other structure in honor of an individual who is
10 serving as a Member of Congress.”.
