RESOLUTION

Providing for consideration of the bill (H.R. 4461) making appropriations for Agriculture, Rural Development, Food and Drug Administration, and Related Agencies programs for the fiscal year ending September 30, 2001, and for other purposes.

- 1 Resolved, That at any time after the adoption of this
- 2 resolution the Speaker may, pursuant to clause 2(b) of
- 3 rule XVIII, declare the House resolved into the Committee
- 4 of the Whole House on the state of the Union for consider-

- 1 ation of the bill (H.R. 4461) making appropriations for
- 2 Agriculture, Rural Development, Food and Drug Adminis-
- 3 tration, and Related Agencies programs for the fiscal year
- 4 ending September 30, 2001, and for other purposes. The
- 5 first reading of the bill shall be dispensed with. All points
- 6 of order against consideration of the bill are waived. Gen-
- 7 eral debate shall be confined to the bill and shall not ex-
- 8 ceed one hour equally divided and controlled by the chair-
- 9 man and ranking minority member of the Committee on
- 10 Appropriations. After general debate the bill shall be con-
- 11 sidered for amendment under the five-minute rule. When
- 12 the reading for amendment reaches title VIII, that title
- 13 shall be considered as read. The amendments printed in
- 14 the report of the Committee on Rules accompany this res-
- 15 olution shall be considered as adopted in the House and
- 16 in the Committee of the Whole. Points of order against
- 17 provisions in the bill, as amended, for failure to comply
- 18 with clause 2 of rule XXI are waived except as follows:
- 19 page 74, line 19, through page 75, line 4; page 85, line
- 20 6, through page 96, line 4. During consideration of the
- 21 bill for amendment, the Chairman of the Committee of
- 22 the Whole may accord priority in recognition on the basis
- 23 of whether the Member offering an amendment has caused
- 24 it to be printed in the portion of the Congressional Record
- 25 designated for that purpose in clause 8 of rule XVIII.

- 1 Amendments so printed shall be considered as read. The
- 2 Chairman of the Committee of the Whole may: (1) post-
- 3 pone until a time during further consideration in the Com-
- 4 mittee of the Whole a request for a recorded vote on any
- 5 amendment; and (2) reduce to five minutes the minimum
- 6 time for electronic voting on any postponed question that
- 7 follows another electronic vote without intervening busi-
- 8 ness, provided that the minimum time for electronic voting
- 9 on the first in any series of questions shall be 15 minutes.
- 10 At the conclusion of consideration of the bill for amend-
- 11 ment the Committee shall rise and report the bill, as
- 12 amended, to the House with such amendments as may
- 13 have been adopted. The previous question shall be consid-
- 14 ered as ordered on the bill and amendments thereto to
- 15 final passage without intervening motion except one mo-
- 16 tion to recommit with or without instructions.
