Ms. PRYCE of Ohio, from the Committee on Rules, reported the following resolution; which was referred to the House Calendar and ordered to be printed

RESOLUTION

Providing for consideration of the bill (H.R. 4577) making appropriations for the Departments of Labor, Health and Human Services, and Education, and related agencies for the fiscal year ending September 30, 2001, and for other purposes.

1 *Resolved*, That at any time after the adoption of this
2 resolution the Speaker may, pursuant to clause 2(b) of
3 rule XVIII, declare the House resolved into the Committee
4 of the Whole House on the state of the Union for consider-

1 tion of the bill (H.R. 4577) making appropriations for
2 the Departments of Labor, Health and Human Services,
3 and Education, and related agencies for the fiscal year
4 ending September 30, 2001, and for other purposes. The
5 first reading of the bill shall be dispensed with. All points
6 of order against consideration of the bill are waived. Gen-
7 eral debate shall be confined to the bill and shall not ex-
8 ceed one hour equally divided and controlled by the chair-
9 man and ranking minority member of the Committee on
10 Appropriations. After general debate the bill shall be con-
11 sidered for amendment under the five-minute rule. The
12 amendments printed in part A of the report of the Com-
13 mittee on Rules accompanying this resolution shall be con-
14 sidered as adopted in the House and in the Committee
15 of the Whole. Points of order against provisions in the
16 bill, as amended, for failure to comply with clause 2 of
17 rule XXI are waived except as follows: beginning with
18 “: *Provided*” on page 44, line 4, through “as amended”
19 on line 14. Where points of order are waived against a
20 part of a paragraph, points of order against a provision
21 in another part of such paragraph may be made only
22 against such provision and not against the entire para-
23 graph. The amendment printed in part B of the report
24 of the Committee on Rules may be offered only by a Mem-
25 ber designated in the report and only at the appropriate

1 point in the reading of the bill, shall be considered as read,
2 shall be debatable for the time specified in the report
3 equally divided and controlled by the proponent and an
4 opponent, shall not be subject to amendment, and shall
5 not be subject to a demand for division of the question
6 in the House or in the Committee of the Whole. All points
7 of order against the amendment printed in part B of the
8 report are waived. During consideration of the bill for fur-
9 ther amendment, the Chairman of the Committee of the
10 Whole may accord priority in recognition on the basis of
11 whether the Member offering an amendment has caused
12 it to be printed in the portion of the Congressional Record
13 designated for that purpose in clause 8 of rule XVIII.
14 Amendments so printed shall be considered as read. The
15 Chairman of the Committee of the Whole may: (1) post-
16 pone until a time during further consideration in the Com-
17 mittee of the Whole a request for a recorded vote on any
18 amendment; and (2) reduce to five minutes the minimum
19 time for electronic voting on any postponed question that
20 follows another electronic vote without intervening busi-
21 ness, provided that the minimum time for electronic voting
22 on the first in any series of questions shall be 15 minutes.
23 During consideration of the bill, points of order against
24 amendments for failure to comply with clause 2(e) of rule
25 XXI are waived. At the conclusion of consideration of the

1 bill for amendment the Committee shall rise and report
2 the bill, as amended, to the House with such further
3 amendments as may have been adopted. The previous
4 question shall be considered as ordered on the bill and
5 amendments thereto to final passage without intervening
6 motion except one motion to recommit with or without in-
7 structions.
