A BILL

To amend title 10, United States Code, to permit retired members of the Armed Forces who have a service-connected disability to receive military retired pay concurrently with veterans' disability compensation.

- 1 Be it enacted by the Senate and House of Representa-
- 2 tives of the United States of America in Congress assembled,
- 3 SECTION 1. SHORT TITLE.
- 4 This Act may be cited as the "Military Retirement
- 5 Equity Act of 1999".

1	SEC. 2. CONCURRENT PAYMENT OF RETIRED PAY AND
2	COMPENSATION.
3	(a) Limitation on Duplication of Benefits.—
4	Chapter 71 of title 10, United States Code, is amended
5	by adding at the end the following new section:
6	"§ 1413. Concurrent payment of retired pay and vet-
7	erans' disability compensation
8	"(a) Subject to subsection (b), a person entitled to
9	retired pay other than under chapter 61 of this title may
10	be paid that pay concurrently with the payment of vet-
11	erans' disability compensation for a service-connected dis-
12	ability if the person's entitlement to retired pay is based
13	solely on—
14	"(1) the person's age;
15	"(2) service in the uniformed services of not
16	less than 20 years that are creditable for computa-
17	tion of such retired pay; or
18	"(3) both the person's age and service of not
19	less than 20 years that are creditable for computa-
20	tion of such retired pay.
21	"(b) In the case of a person described in subsection
22	(a) who is receiving both retired pay and veterans' dis-
23	ability compensation, the amount of retired pay paid such
24	person shall be reduced (but not below zero) based on the
25	rating of the person's disability for veterans' disability
26	compensation purposes as follows:

- 1 "(1) If and while the disability is rated 10 per-2 cent, by the amount equal to 90 percent of the 3 amount of the disability compensation paid such per-4 son.
- "(2) If and while the disability is rated 20 per-5 6 cent, by the amount equal to 80 percent of the 7 amount of the disability compensation paid such per-8 son.
 - "(3) If and while the disability is rated 30 percent, by the amount equal to 70 percent of the amount of the disability compensation paid such person.
 - "(4) If and while the disability is rated 40 percent, by the amount equal to 60 percent of the amount of the disability compensation paid such person.
 - "(5) If and while the disability is rated 50 percent, by the amount equal to 50 percent of the amount of the disability compensation paid such person.
- "(6) If and while the disability is rated 60 per-22 cent, by the amount equal to 40 percent of the 23 amount of the disability compensation paid such per-24 son.

- 17 "(1) The term 'retired pay' includes retainer
- pay and emergency officers' retirement pay.
- 19 "(2) The term 'veterans' disability compensa-
- 20 tion' has the meaning given the term 'compensation'
- 21 in section 101(12) of title 38.".
- 22 (b) Clerical Amendment.—The table of sections
- 23 at the beginning of such chapter is amended by adding
- 24 at the end the following new item:

[&]quot;1413. Concurrent payment of retired pay and veterans' disability compensation.".

1 SEC. 3. EFFECTIVE DATE AND PROHIBITION ON RETRO-

- 2 **ACTIVE BENEFITS.**
- 3 (a) In General.—The amendments made by this
- 4 Act shall take effect on October 1, 1999.
- 5 (b) Retroactive Benefits.—No benefits shall be
- 6 paid to any person by reason of this Act for any period
- 7 before the effective date specified in subsection (a).
