AN ACT

To amend the Public Health Service Act to provide support for the modernization and construction of biomedical and behavioral research facilities and laboratory instrumentation.

- 1 Be it enacted by the Senate and House of Representa-
- 2 tives of the United States of America in Congress assembled,
- 3 SECTION 1. SHORT TITLE.
- 4 This Act may be cited as the "Twenty-First Century
- 5 Research Laboratories Act".

1	SEC. 2. FINDINGS.
2	Congress finds that—
3	(1) the National Institutes of Health is the
4	principal source of Federal funding for medical re-
5	search at universities and other research institutions
6	in the United States;
7	(2) the National Institutes of Health has re-
8	ceived a substantial increase in research funding
9	from Congress for the purpose of expanding the na-
10	tional investment of the United States in behavioral
11	and biomedical research;
12	(3) the infrastructure of our research institu-
13	tions is central to the continued leadership of the
14	United States in medical research;
15	(4) as Congress increases the investment in cut-
16	ting-edge basic and clinical research, it is critical
17	that Congress also examine the current quality of
18	the laboratories and buildings where research is
19	being conducted, as well as the quality of laboratory
20	equipment used in research;
21	(5) many of the research facilities and labora-
22	tories in the United States are outdated and inad-
23	equate;
24	(6) the National Science Foundation found, in
25	a 1998 report on the status of biomedical research

facilities, that over 60 percent of research-per-

1	forming institutions indicated that they had an inad-
2	equate amount of medical research space;
3	(7) the National Science Foundation reports
4	that academic institutions have deferred nearly
5	\$11,000,000,000 in renovation and construction
6	projects because of a lack of funds; and
7	(8) future increases in Federal funding for the
8	National Institutes of Health must include increased
9	support for the renovation and construction of extra-
10	mural research facilities in the United States and
11	the purchase of state-of-the-art laboratory instru-
12	mentation.

3	"(2) Construction and cost of construc-
4	TION.—For purposes of this section, the terms 'con-
5	struction' and 'cost of construction' include the con-
6	struction of new buildings and the expansion, ren-
7	ovation, remodeling, and alteration of existing build-
8	ings, including architects' fees, but do not include
9	the cost of acquisition of land or off-site improve-
10	ments.
11	"(b) Scientific and Technical Review Boards
12	FOR MERIT-BASED REVIEW OF PROPOSALS.—
13	"(1) In general: approval as precondition
14	TO GRANTS.—
15	"(A) ESTABLISHMENT.—There is estab-
16	lished within the Center a Scientific and Tech-
17	nical Review Board on Biomedical and Behav-
18	ioral Research Facilities (referred to in this sec-
19	tion as the 'Board').
20	"(B) REQUIREMENT.—The Director of the
21	Center may approve an application for a grant
22	under subsection (a) only if the Board has
23	under paragraph (2) recommended the applica-
24	tion for approval.
25	"(2) Duties.—

- "(A) ADVICE.—The Board shall provide advice to the Director of the Center and the advisory council established under section 480 (in this section referred to as the 'Advisory Council') in carrying out this section.
 - "(B) Determination of Merit.—In carrying out subparagraph (A), the Board shall make a determination of the merit of each application submitted for a grant under subsection (a), after consideration of the requirements established in subsection (c), and shall report the results of the determination to the Director of the Center and the Advisory Council. Such determinations shall be conducted in a manner consistent with procedures established under section 492.
 - "(C) AMOUNT.—In carrying out subparagraph (A), the Board shall, in the case of applications recommended for approval, make recommendations to the Director and the Advisory Council on the amount that should be provided under the grant.
 - "(D) ANNUAL REPORT.—In carrying out subparagraph (A), the Board shall prepare an annual report for the Director of the Center

1	and the Advisory Council describing the activi-
2	ties of the Board in the fiscal year for which
3	the report is made. Each such report shall be
4	available to the public, and shall—
5	"(i) summarize and analyze expendi-
6	tures made under this section;
7	"(ii) provide a summary of the types,
8	numbers, and amounts of applications that
9	were recommended for grants under sub-
10	section (a) but that were not approved by
11	the Director of the Center; and
12	"(iii) contain the recommendations of
13	the Board for any changes in the adminis-
14	tration of this section.
15	"(3) Membership.—
16	"(A) In general.—Subject to subpara-
17	graph (B), the Board shall be composed of 15
18	members to be appointed by the Director of the
19	Center, and such ad-hoc or temporary members
20	as the Director of the Center determines to be
21	appropriate. All members of the Board, includ-
22	ing temporary and ad-hoc members, shall be
23	voting members.
24	"(B) Limitation.—Not more than 3 indi-
25	viduals who are officers or employees of the

1	Federal Government may serve as members of
2	the Board.
3	"(4) Certain requirements regarding
4	MEMBERSHIP.—In selecting individuals for member-
5	ship on the Board, the Director of the Center shall
6	ensure that the members are individuals who, by vir-
7	tue of their training or experience, are eminently
8	qualified to perform peer review functions. In select-
9	ing such individuals for such membership, the Direc-
10	tor of the Center shall ensure that the members of
11	the Board collectively—
12	"(A) are experienced in the planning, con-
13	struction, financing, and administration of enti-
14	ties that conduct biomedical or behavioral re-
15	search sciences;
16	"(B) are knowledgeable in making deter-
17	minations of the need of entities for biomedical
18	or behavioral research facilities, including such
19	facilities for the dentistry, nursing, pharmacy,
20	and allied health professions;
21	"(C) are knowledgeable in evaluating the
22	relative priorities for applications for grants
23	under subsection (a) in view of the overall re-
24	search needs of the United States; and

1	"(D) are experienced with emerging cen-
2	ters of excellence, as described in subsection
3	(c)(2).
4	"(5) Certain authorities.—
5	"(A) Workshops and conferences.—In
6	carrying out paragraph (2), the Board may con-
7	vene workshops and conferences, and collect
8	data as the Board considers appropriate.
9	"(B) Subcommittees.—In carrying out
10	paragraph (2), the Board may establish sub-
11	committees within the Board. Such subcommit-
12	tees may hold meetings as determined necessary
13	to enable the subcommittee to carry out its du-
14	ties.
15	"(6) Terms.—
16	"(A) In general.—Except as provided in
17	subparagraph (B), each appointed member of
18	the Board shall hold office for a term of 4
19	years. Any member appointed to fill a vacancy
20	occurring prior to the expiration of the term for
21	which such member's predecessor was ap-
22	pointed shall be appointed for the remainder of
23	the term of the predecessor.
24	"(B) Staggered terms.—Members ap-
25	pointed to the Board shall serve staggered

1	terms as specified by the Director of the Center
2	when making the appointments.
3	"(C) REAPPOINTMENT.—No member of
4	the Board shall be eligible for reappointment to
5	the Board until 1 year has elapsed after the
6	end of the most recent term of the member.
7	"(7) Compensation.—Members of the Board
8	who are not officers or employees of the United
9	States shall receive for each day the members are
10	engaged in the performance of the functions of the
11	Board compensation at the same rate received by
12	members of other national advisory councils estab-
13	lished under this title.
14	"(c) Requirements for Grants.—
15	"(1) In general.—The Director of the Center
16	may make a grant under subsection (a) only if the
17	applicant for the grant meets the following condi-
18	tions:
19	"(A) The applicant is determined by such
20	Director to be competent to engage in the type
21	of research for which the proposed facility is to
22	be constructed.
23	"(B) The applicant provides assurances
24	satisfactory to the Director that—

1	"(i) for not less than 20 years after
2	completion of the construction involved, the
3	facility will be used for the purposes of the
4	research for which it is to be constructed;
5	"(ii) sufficient funds will be available
6	to meet the non-Federal share of the cost
7	of constructing the facility;
8	"(iii) sufficient funds will be available,
9	when construction is completed, for the ef-
10	fective use of the facility for the research
11	for which it is being constructed; and
12	"(iv) the proposed construction will
13	expand the applicant's capacity for re-
14	search, or is necessary to improve or main-
15	tain the quality of the applicant's research.
16	"(C) The applicant meets reasonable quali-
17	fications established by the Director with re-
18	spect to—
19	"(i) the relative scientific and tech-
20	nical merit of the applications, and the rel-
21	ative effectiveness of the proposed facili-
22	ties, in expanding the capacity for bio-
23	medical or behavioral research and in im-
24	proving the quality of such research;

1	"(ii) the quality of the research or
2	training, or both, to be carried out in the
3	facilities involved;
4	"(iii) the congruence of the research
5	activities to be carried out within the facil-
6	ity with the research and investigator man-
7	power needs of the United States; and
8	"(iv) the age and condition of existing
9	research facilities.
10	"(D) The applicant has demonstrated a
11	commitment to enhancing and expanding the
12	research productivity of the applicant.
13	"(2) Institutions of emerging excel-
14	LENCE.—From the amount appropriated under sub-
15	section (i) for a fiscal year up to \$50,000,000, the
16	Director of the Center shall make available 25 per-
17	cent of such amount, and from the amount appro-
18	priated under such subsection for a fiscal year that
19	is over \$50,000,000, the Director of the Center shall
20	make available up to 25 percent of such amount, for
21	grants under subsection (a) to applicants that in ad-
22	dition to meeting the requirements established in
23	paragraph (1), have demonstrated emerging excel-
24	lence in biomedical or behavioral research, as fol-
25	lows:

1	"(A) The applicant has a plan for research
2	or training advancement and possesses the abil-
3	ity to carry out the plan.
4	"(B) The applicant carries out research
5	and research training programs that have a
6	special relevance to a problem, concern, or
7	unmet health need of the United States.
8	"(C) The applicant has been productive in
9	research or research development and training.
10	"(D) The applicant—
11	"(i) has been designated as a center
12	of excellence under section 739;
13	"(ii) is located in a geographic area
14	whose population includes a significant
15	number of individuals with health status
16	deficit, and the applicant provides health
17	services to such individuals; or
18	"(iii) is located in a geographic area
19	in which a deficit in health care tech-
20	nology, services, or research resources may
21	adversely affect the health status of the
22	population of the area in the future, and
23	the applicant is carrying out activities with
24	respect to protecting the health status of
25	such population.

1	"(d) Requirement of Application.—The Director
2	of the Center may make a grant under subsection (a) only
3	if an application for the grant is submitted to the Director
4	and the application is in such form, is made in such man-
5	ner, and contains such agreements, assurances, and infor-
6	mation as the Director determines to be necessary to carry
7	out this section.
8	"(e) Amount of Grant; Payments.—
9	"(1) Amount.—The amount of any grant
10	awarded under subsection (a) shall be determined by
11	the Director of the Center, except that such amount
12	shall not exceed—
13	"(A) 50 percent of the necessary cost of
14	the construction of a proposed facility as deter-
15	mined by the Director; or
16	"(B) in the case of a multipurpose facility,
17	40 percent of that part of the necessary cost of
18	construction that the Director determines to be
19	proportionate to the contemplated use of the fa-
20	cility.
21	"(2) Reservation of amounts.—On the ap-
22	proval of any application for a grant under sub-
23	section (a), the Director of the Center shall reserve,
24	from any appropriation available for such grants,
25	the amount of such grant, and shall pay such

amount, in advance or by way of reimbursement,
and in such installments consistent with the construction progress, as the Director may determine
appropriate. The reservation of any amount by the
Director under this paragraph may be amended by
the Director, either on the approval of an amendment of the application or on the revision of the estimated cost of construction of the facility.

- "(3) EXCLUSION OF CERTAIN COSTS.—In determining the amount of any grant under subsection (a), there shall be excluded from the cost of construction an amount equal to the sum of—
 - "(A) the amount of any other Federal grant that the applicant has obtained, or is assured of obtaining, with respect to construction that is to be financed in part by a grant authorized under this section; and
 - "(B) the amount of any non-Federal funds required to be expended as a condition of such other Federal grant.
- "(4) WAIVER OF LIMITATIONS.—The limitations imposed under paragraph (1) may be waived at the discretion of the Director for applicants meeting the conditions described in subsection (c).

- 1 "(f) RECAPTURE OF PAYMENTS.—If, not later than
- 2 20 years after the completion of construction for which
- 3 a grant has been awarded under subsection (a)—
- 4 "(1) the applicant or other owner of the facility
- 5 shall cease to be a public or non profit private enti-
- 6 ty; or
- 7 "(2) the facility shall cease to be used for the
- 8 research purposes for which it was constructed (un-
- 9 less the Director determines, in accordance with reg-
- 10 ulations, that there is good cause for releasing the
- applicant or other owner from obligation to do so);
- 12 the United States shall be entitled to recover from the ap-
- 13 plicant or other owner of the facility the amount bearing
- 14 the same ratio to the current value (as determined by an
- 15 agreement between the parties or by action brought in the
- 16 United States District Court for the district in which such
- 17 facility is situated) of the facility as the amount of the
- 18 Federal participation bore to the cost of the construction
- 19 of such facility.
- 20 "(g) Guidelines.—Not later than 6 months after
- 21 the date of the enactment of this section, the Director of
- 22 the Center, after consultation with the Advisory Council,
- 23 shall issue guidelines with respect to grants under sub-
- 24 section (a).

- 1 "(h) REPORT TO CONGRESS.—The Director of the
- 2 Center shall prepare and submit to the appropriate com-
- 3 mittees of Congress a biennial report concerning the sta-
- 4 tus of the biomedical and behavioral research facilities and
- 5 the availability and condition of technologically sophisti-
- 6 cated laboratory equipment in the United States. Such re-
- 7 ports shall be developed in concert with the report pre-
- 8 pared by the National Science Foundation on the needs
- 9 of research facilities of universities as required under sec-
- 10 tion 108 of the National Science Foundation Authoriza-
- 11 tion Act for Fiscal Year 1986 (42 U.S.C. 1886).
- 12 "(i) AUTHORIZATION OF APPROPRIATIONS.—For the
- 13 purpose of carrying out this section, there are authorized
- 14 to be appropriated \$250,000,000 for fiscal year 2001, and
- 15 such sums as may be necessary for each of the fiscal years
- 16 2002 and 2003.".
- 17 SEC. 4. CONSTRUCTION PROGRAM FOR NATIONAL PRI-
- 18 MATE RESEARCH CENTERS.
- 19 Section 481B(a) of the Public Health Service Act (42
- 20 U.S.C. 287a-3(a)) is amended by striking "1994" and all
- 21 that follows through "\$5,000,000" and inserting "2000
- 22 through 2002, reserve from the amounts appropriated
- 23 under section 481A(i) such sums as necessary".

1 SEC. 5. SHARED INSTRUMENTATION GRANT PROGRAM.

2	(a) AUTHORIZATION OF APPROPRIATIONS.—There is
3	authorized to be appropriated \$100,000,000 for fiscal year
4	2000, and such sums as may be necessary for each subse-
5	quent fiscal year, to enable the Secretary of Health and
6	Human Services, acting through the Director of the Na-
7	tional Center for Research Resources, to provide for the
8	continued operation of the Shared Instrumentation Grant
9	Program (initiated in fiscal year 1992 under the authority
10	of section 479 of the Public Health Service Act (42 U.S.C.
11	287 et seq.)).
12	(b) REQUIREMENTS FOR GRANTS.—In determining
13	whether to award a grant to an applicant under the pro-
14	gram described in subsection (a), the Director of the Na-
15	tional Center for Research Resources shall consider—
16	(1) the extent to which an award for the spe-
17	cific instrument involved would meet the scientific
18	needs and enhance the planned research endeavors
19	of the major users by providing an instrument that
20	is unavailable or to which availability is highly lim-
21	ited;
22	(2) with respect to the instrument involved, the
23	availability and commitment of the appropriate tech-
24	nical expertise within the major user group or the
25	applicant institution for use of the instrumentation;

1	(3) the adequacy of the organizational plan for
2	the use of the instrument involved and the internal
3	advisory committee for oversight of the applicant, in-
4	cluding sharing arrangements if any;
5	(4) the applicant's commitment for continued
6	support of the utilization and maintenance of the in-
7	strument; and
8	(5) the extent to which the specified instrument
9	will be shared and the benefit of the proposed in-
10	strument to the overall research community to be
11	served.
12	(e) Peer Review.—In awarding grants under the
13	program described in subsection (a) Director of the Na-
14	tional Center for Research Resources shall comply with
15	the peer review requirements in section 492 of the Public
16	Health Service Act (42 U.S.C. 289a).
