A BILL

To amend section 4532 of title 10, United States Code, to provide for the coverage and treatment of overhead costs of United States factories and arsenals when not making supplies for the Army, and for other purposes.

- 1 Be it enacted by the Senate and House of Representa-
- 2 tives of the United States of America in Congress assembled,
- 3 SECTION 1. OVERHEAD COSTS OF UNITED STATES FAC-
- 4 TORIES AND ARSENALS WHEN NOT MAKING
- 5 SUPPLIES FOR THE ARMY.
- 6 (a) FINDING.—Congress makes the following find-
- 7 ings:

- 1 (1) Factories and arsenals owned by the United
- 2 States play a vital role in the national defense by en-
- 3 suring the making of supplies for the Department of
- 4 the Army.
- 5 (2) The vital role of such factories and arsenals
- 6 in the national defense is not diminished by their
- 7 unutilization or underutilization in peacetime.
- 8 (b) Overhead Costs of Factories and Arsenals
- 9 When Unutilized or Underutilized.—Section 4532
- 10 of title 10, United States Code, is amended by adding at
- 11 the end the following:
- 12 "(c) Overhead Costs When Unutilized or Un-
- 13 DERUTILIZED.—(1) The Secretary shall submit to Con-
- 14 gress each year, together with the President's budget for
- 15 the fiscal year beginning in such year under section
- 16 1105(a) of title 31, an estimate of the funds to be required
- 17 in the fiscal year in order to cover any overhead costs at
- 18 factories and arsenals referred to in subsection (a) that
- 19 result from the unutilization or underutilization of such
- 20 factories and arsenals in the fiscal year due to low produc-
- 21 tion requirements of the Department of the Army.
- "(2) Funds appropriated to the Secretary for a fiscal
- 23 year for costs described in paragraph (1) shall be available
- 24 to the Secretary in such fiscal year to cover such costs.

- 1 "(3) In determining the cost of making a supply or
- 2 other good, other than a supply for the Department of
- 3 the Army, at a factory or arsenal referred to in subsection
- 4 (a), the Secretary shall not take into account any overhead
- 5 cost covered with funds available to the Secretary under
- 6 paragraph (2).".
- 7 (c) STYLISTIC AMENDMENTS.—That section is fur-
- 8 ther amended—
- 9 (1) in subsection (a), by inserting "AUTHORITY
- To Make Supplies.—" before "The Secretary of
- 11 the Army"; and
- 12 (2) in subsection (b), by inserting "Aboli-
- 13 TION.—" before "The Secretary".
