A BILL

To authorize a comprehensive program of support for victims of torture abroad.

- 1 Be it enacted by the Senate and House of Representa-
- 2 tives of the United States of America in Congress assembled,
- 3 SECTION 1. SHORT TITLE.
- 4 This Act may be cited as the "Torture Victims Relief
- 5 Reauthorization Act of 1999".
- 6 SEC. 2. FOREIGN TREATMENT CENTERS FOR VICTIMS OF
- 7 TORTURE.
- 8 (a) AUTHORIZATION OF APPROPRIATIONS.—Of the
- 9 amounts authorized to be appropriated for fiscal years
- 10 2001, 2002, and 2003 pursuant to chapter 1 of part I

- 1 of the Foreign Assistance Act of 1961, there are author-
- 2 ized to be appropriated to the President \$10,000,000 for
- 3 fiscal year 2001, \$10,000,000 for fiscal year 2002, and
- 4 \$10,000,000 for fiscal year 2003 to carry out section 129
- 5 of the Foreign Assistance Act of 1961.
- 6 (b) Availability of Funds.—Amounts appro-
- 7 priated pursuant to this section shall remain available
- 8 until expended.

9 SEC. 3. DOMESTIC TREATMENT CENTERS FOR VICTIMS OF

- 10 TORTURE.
- 11 (a) AUTHORIZATION OF APPROPRIATIONS.—Of the
- 12 amounts authorized to be appropriated for the Depart-
- 13 ment of Health and Human Services for fiscal years 2001,
- 14 2002, and 2003, there are authorized to be appropriated
- 15 to carry out subsection (a) of section 5 of the Torture Vic-
- 16 tims Relief Act of 1998 (22 U.S.C. 2152) \$10,000,000
- 17 for fiscal year 2001, \$10,000,000 for fiscal year 2002, and
- 18 + 10,000,000 for fiscal year 2003.
- 19 (b) Availability of Funds.—Amounts appro-
- 20 priated pursuant to this section shall remain available
- 21 until expended.
- 22 SEC. 4. MULTILATERAL ASSISTANCE.
- 23 (a) Funding.—Of the amounts authorized to be ap-
- 24 propriated for fiscal years 2001, 2002, and 2003 pursuant
- 25 to chapter 3 of part I of the Foreign Assistance Act of

1	1961, there are authorized to be appropriated to the Presi-
2	dent for contribution to the United Nations Voluntary
3	Fund for Victims of Torture (in this section referred to
4	as the "Fund") the following amounts for the following
5	fiscal years:
6	(1) FISCAL YEAR 2001.—For fiscal year 2001.
7	\$5,000,000.
8	(2) FISCAL YEAR 2002.—For fiscal year 2002,
9	\$5,000,000.
10	(3) FISCAL YEAR 2003.—For fiscal year 2003.
11	\$5,000,000.
12	(b) Availability of Funds.—Amounts appro-
13	priated pursuant to subsection (a) shall remain available
14	until expended.
15	(c) Sense of the Congress.—It is the sense of the
16	Congress that the President, acting through the United
17	States Permanent Representative to the United Nations
18	should—
19	(1) request the Fund—
20	(A) to find new ways to support and pro-
21	tect treatment centers and programs that are
22	carrying out rehabilitative services for victims
23	of torture; and
24	(B) to encourage the development of new
25	such centers and programs:

1	(2) use the voice and vote of the United States
2	to support the work of the Special Rapporteur or
3	Torture and the Committee Against Torture estab-
4	lished under the Convention Against Torture and
5	Other Cruel, Inhuman or Degrading Treatment or
6	Punishment; and
7	(3) use the voice and vote of the United States
8	to establish a country rapporteur or similar proce-
9	dural mechanism to investigate human rights viola-
10	tions in a country if either the Special Rapporteur
11	or the Committee Against Torture indicates that a
12	systematic practice of torture is prevalent in that
13	country.
14	SEC. 5. REPORTING REQUIREMENT.
15	Not later than 90 days after the date of enactment
16	of this Act, the Secretary of State shall submit a report
17	to the Committee on Foreign Relations of the Senate and
18	the Committee on International Relations of the House
19	of Representatives on the specialized training for Foreign
20	Service officers required by section 7 of the Torture Vic-
21	tims Relief Act of 1998 (Public Law 105–320). The report
22	shall include detailed information regarding—
23	(1) efforts by the Department of State to imple-

ment the specialized training requirement;

- 1 (2) the curriculum that is being used in the 2 specialized training;
 - (3) the number of Foreign Service officers who have received the specialized training as of the date of the report; and
 - (4) the nongovernmental organizations that have been involved in the development of the specialized training curriculum or in providing the specialized training, and the nature and extent of that involvement.
