- 3 (a) Restriction.—(1) Chapter 443 of title 10,

- 8 "(a) Limitation on Resale or Other Trans-
- 9 FER.—Whenever the Secretary of the Army carries out a
- 10 disposal (by sale or otherwise) of armor piercing ammuni-
- 11 tion, or a component of armor piercing ammunition, the
- 12 Secretary shall require as a condition of the disposal that
- 13 the recipient agree in writing not to sell or otherwise
- 14 transfer any of the ammunition (reconditioned or other-
- 15 wise), or any component of that ammunition, to any pur-
- 16 chaser in the United States other than a law enforcement
- 17 or other governmental agency.
- 18 "(b) Definition.—In this section, the term 'armor
- 19 piercing ammunition' means a center-fire cartridge the
- 20 military designation of which includes the term 'armor
- 21 penetrator' or 'armor piercing', including a center-fire car-
- 22 tridge designated as armor piercing incendiary (API) or
- 23 armor-piercing incendiary-tracer (API–T).".

- 1 (b) APPLICABILITY.—Section 4688 of title 10, United
- 2 States Code (as added by subsection (a)), shall apply with
- 3 respect to any disposal of ammunition or components re-
- 4 ferred to in that section after the date of the enactment
