AN ACT

To authorize the Secretary of Agriculture to sell or exchange all or part of certain administrative sites and other land in the Black Hills National Forest and to use funds derived from the sale or exchange to acquire replacement sites and to acquire or construct administrative improvements in connection with the Black Hills National Forest.

- 1 Be it enacted by the Senate and House of Representa-

SECTION 1. SALE OR EXCHANGE OF LAND.

- 2 (a) IN GENERAL.—The Secretary of Agriculture (re-
- 3 ferred to in this Act as the "Secretary") may, under such
- 4 terms and conditions as the Secretary may prescribe, sell
- 5 or exchange any right, title, and interest of the United
- 6 States in and to the approximately 367 acres contained
- 7 in the following parcels of land in the State of South Da-

- 18 (b) APPLICABLE AUTHORITIES.—Except as other-
- 19 wise provided in this Act, any sale or exchange of land
- 20 described in subsection (a) shall be subject to laws (includ-
- 21 ing regulations) applicable to the conveyance and acquisi-
- 22 tion of land for National Forest System purposes.
- 23 (c) Cash Equalization.—Notwithstanding any
- 24 other provision of law, the Secretary may accept cash
- 25 equalization payments in excess of 25 percent of the total

1	value of the land described in subsection (a) from any ex-
2	change under subsection (a).
3	(d) Solicitations of Offers.—
4	(1) In general.—In carrying out this Act, the
5	Secretary may use solicitations of offers for sale or
6	exchange under this Act on such terms and condi-
7	tions as the Secretary may prescribe.
8	(2) Rejection of offers.—The Secretary
9	may reject any offer under this Act if the Secretary
10	determines that the offer is not adequate or not in
11	the public interest.
12	SEC. 2. DISPOSITION OF FUNDS.
13	Any funds received by the Secretary through sale or
14	by cash equalization from an exchange—
15	(1) shall be deposited into the fund established
16	by Public Law 90–171 (commonly known as the
17	"Sisk Act") (16 U.S.C. 484a); and
18	(2) shall be available for expenditure, on appro-
19	priation, for—
20	(A) the acquisition of land and interests in
21	land in the State of South Dakota; and
22	(B) the acquisition or construction of ad-
23	ministrative improvements in connection with
24	the Black Hills National Forest.

1 SEC. 3. AUTHORIZATION OF APPROPRIATIONS.

- 2 There are authorized to be appropriated such sums
- 3 as are necessary to carry out this Act.
