A BILL

To direct the Secretary of Agriculture to convey certain land to Federal Energy Regulatory Commission permit holders.

- 1 Be it enacted by the Senate and House of Representa-
- 2 tives of the United States of America in Congress assembled,
- 3 SECTION 1. CONVEYANCE.
- 4 (a) In General.—Notwithstanding any provision in
- 5 the record of decision adopting the Northwest Forest Plan
- 6 dated April 13, 1994 (59 Fed. Reg. 18788), the Secretary
- 7 of Agriculture shall convey to the permit holders described
- 8 in subsection (b), at fair market value and by quitclaim
- 9 deed, the parcels of land (including roads) necessary for
- 10 development of the small hydroelectric power project sites,

- 1 located in whole or in part within the Mt. Baker/
- 2 Snoqualmie National Forest, Washington, described as
- 3 follows:
- 4 (1) Anderson Creek, comprising approximately
- 5 26.3 acres, Sections 21, 28, 29, and 32, T37N, R9E
- 6 Willamette meridian.
- 7 (2) Irene Creek, comprising approximately 10.3
- 8 acres, T35N, R12E, Sections 18 and 19, Willamette
- 9 meridian.
- 10 (3) Martin Creek, comprising approximately
- 11 14.13 acres, T26N, RI2E, Sections 12, 13, 24, and
- 12 25, and R13E, Section 8, Willamette meridian.
- 13 (4) Big/Grade Creeks, comprising approxi-
- 14 mately 19.96 acres, T33N, R11E, Sections 7, 8, 9,
- 15 17, and 18, Willamette meridian.
- 16 (5) Cumberland Creek, comprising approxi-
- mately 8.46 acres, T35N, R6E, Sections 23, 24, and
- 18 25, Willamette meridian.
- 19 (6) O'Toole Creek, comprising approximately
- 20 10.0 acres, T35N, R7E, Sections 28, 29, and 33,
- Willamette meridian.
- 22 (b) Permit Holders.—The permit holders de-
- 23 scribed in this subsection are the persons holding prelimi-
- 24 nary permits issued by, or having filed license applications
- 25 with, the Federal Energy Regulatory Commission covering

- 1 the parcels described in subsection (a) during the period
- 2 beginning on January 1, 1990, and ending on December
- 3 31, 1996.
- 4 (c) Timing.—A conveyance under subsection (a)
- 5 shall be made as soon as practicable after receipt of a writ-
- 6 ten request made by a permit holder that—
- 7 (1) describes the Federal land or other real
- 8 property interest needed for project development;
- 9 and
- 10 (2) sets forth a fair market price, which shall
- 11 not include the value of timber on the land.
- 12 (d) Additional Land.—The Secretary of
- 13 Agriculture—
- 14 (1) shall convey any additional land or property
- interests that may be required under a license issued
- by the Federal Energy Regulatory Commission for a
- project described in subsection (b); but
- 18 (2) may retain in any quitclaim deed an ease-
- ment for public access to Mt. Baker/Snoqualmie Na-
- tional Forest land.
- 21 (e) Consideration.—On removal and sale of timber
- 22 required for project development under a license issued by
- 23 the Federal Energy Regulatory Commission for a parcel,
- 24 the licensee shall pay the net proceeds, if any, of the sale
- 25 to the Secretary of Agriculture.

1	(f) Use of Proceeds.—Proceeds received by the
2	Secretary of Agriculture under subsection (e) shall—
3	(1) be deposited in a separate account in the
4	Treasury of the United States; and
5	(2) remain available to the Secretary of Agri-
6	culture, without further Act of appropriation, for use
7	in watershed and species management activities to
8	ensure proper implementation of the Northwest For-
9	est Plan in the Mt. Baker/Snoqualmie National For-
10	est.
