## A BILL

To amend the Elementary and Secondary Education Act of 1965 to improve literacy through family literacy projects.

- 1 Be it enacted by the Senate and House of Representa-
- 2 tives of the United States of America in Congress assembled,
- 3 SECTION 1. SHORT TITLE.
- 4 This Act may be cited as the "Literacy Involves Fam-
- 5 ilies Together Act".
- 6 SEC. 2. AUTHORIZATION OF APPROPRIATIONS.
- 7 Section 1002(b) of the Elementary and Secondary
- 8 Education Act of 1965 (20 U.S.C. 6302(b)) is amended
- 9 by striking "\$118,000,000 for fiscal year 1995" and in-
