- 4 This Act may be cited as the "Ricky Ray Fairness
- 5 Act of 1999".
- 6 SEC. 2. RELIEF FUND.

- 8 Fund Act of 1998 (42 U.S.C. 300c–22 note) is amended
- 9 by striking "to carry out" and all that follows through

3	SEC. 3. COMPASSIONATE PAYMENTS.
4	Section 102 of the Ricky Ray Hemophilia Relief
5	Fund Act of 1998 (42 U.S.C. 300c–22 note) is amended—
6	(1) in subsection (a)—
7	(A) in the matter preceding paragraph (1),
8	by striking "HIV infection" and inserting "HIV
9	infection, or who is diagnosed with AIDS,"; and
10	(B) in paragraph (1)—
11	(i) by striking "individual has any"
12	and inserting the following: "individual—
13	"(A) has any";
14	(ii) by striking the period and insert-
15	ing "; or"; and
16	(iii) by adding at the end the fol-
17	lowing:
18	"(B) was treated with HIV contaminated
19	blood transfusion, HIV contaminated blood
20	components, or HIV contaminated human tis-
21	sue during the period beginning on January 1,
22	1982, and ending on March 31, 1985."; and
23	(2) in subsection (b), by striking "that the indi-
24	vidual has an HIV infection." and inserting the fol-
25	lowing. "that—

1	(A) the individual has (or had) an HIV in-
2	fection; and
3	(B) in the case of an individual described
4	in subsection (a)(1)(B), the individual was
5	treated with HIV contaminated blood trans-
6	fusion, HIV contaminated blood components, or
7	HIV contaminated human tissue provided by a
8	medical professional during the period described
9	in such subsection.".
