To provide technical corrections to chapter 1513 of title 36, United States Code, relating to the National Fallen Firefighters Foundation.

- 3 SECTION 1. NATIONAL FALLEN FIREFIGHTERS FOUNDA-
- 4 TION TECHNICAL CORRECTIONS ACT OF 2000.
- 5 (a) Short Title.—This Act may be cited as the
- 6 "National Fallen Firefighters Foundation Technical Cor-
- 7 rections Act of 2000".
- 8 (b) Purposes.—Section 151302 of title 36, United
- 9 States Code, is amended—

5	private gifts of property for the benefit of the
6	National Fallen Firefighters' Memorial and the
7	annual memorial service associated with the

11	defined in section 4 of the Federal Fire Preven-
12	tion and Control Act of 1974 (15 U.S.C.
13	2203)), plan, direct, and manage the memorial
14	service referred to in subparagraph (A);";

17	(3) in paragraph (3)—
18	(A) by striking "State and local" and in-
19	serting "Federal, State, and local"; and
20	(B) by striking "and" after the semicolon;

22	inserting a semicolon; and
23	(5) by adding at the end the following:
24	"(5) to provide for a national program to assist
25	families of fallen firefighters and fire departments in

1 dealing with line-of-duty deaths of those firefighters; 2 and 3 "(6) to promote national, State, and local initiatives to increase public awareness of fire and life 4 5 safety.". 6 (c) Board of Directors.—Section 151303 of title 7 36, United States Code, is amended— 8 (1) by striking subsections (f) and (g) and in-9 serting the following: 10 "(f) STATUS AND COMPENSATION.—(1) Appointment to the board shall not constitute employment by or the holding of an office of the United States. 13 "(2) Members of the board shall serve without com-14 pensation."; and (2) in subsection (h), by striking "(h)" and in-15 serting "(g)". 16 17 (d) Officers and Employees.—Section 151304 of title 36, United States Code, is amended— 18 19 (1) in subsection (a), by striking "not more 20 than 2"; and (2) in subsection (b)(1), by striking "are not" 21 and inserting "shall not be considered". 22 23 (e) Support by the Administrator.—Section

151307(a)(1) of title 36, United States Code, is
