A BILL

To allow postal patrons to contribute to funding for domestic violence programs through the voluntary purchase of specially issued postage stamps.

- 1 Be it enacted by the Senate and House of Representa-
- 2 tives of the United States of America in Congress assembled,
- 3 SECTION 1. SHORT TITLE.
- 4 This Act may be cited as the "Stamp Out Domestic
- 5 Violence Act of 2000".
- 6 SEC. 2. SPECIAL POSTAGE STAMPS RELATING TO DOMES-
- 7 TIC VIOLENCE.
- 8 (a) In General.—Chapter 4 of title 39, United
- 9 States Code, is amended by inserting after section 414 the
- 10 following:

| 21 | ``(d)(1) Amounts becoming available for domestic vio- |
| 22 | lence programs under this section shall be paid by the |
| 23 | Postal Service to the Department of Justice. Payments |
| 24 | under this section shall be made under such arrangements |
| 25 | as the Postal Service shall, by mutual agreement with the |
| 26 | Department of Justice, establish in order to carry out the |

- 2 ments, payments to the Department of Justice shall be

- 4 "(2) For purposes of this section, the term 'amounts
- 5 becoming available for domestic violence programs under

- 10 "(B) an amount sufficient to cover reasonable

- ing, sale, and distribution of stamps under this sec-

- 17 "(e) It is the sense of Congress that nothing in this
- 18 section should—
- "(1) directly or indirectly cause a net decrease
- in total funds received by the Department of Justice

- 3 "(f) Special postage stamps under this section shall
- 4 be made available to the public beginning on such date
- 5 as the Postal Service shall by regulation prescribe, but not

- 8 "(g) The Postmaster General shall include in each
- 9 report rendered under section 2402 with respect to any
- 10 period during any portion of which this section is in effect,
- 11 information concerning the operation of this section, ex-
- 12 cept that, at a minimum, each report shall include—
- "(1) the total amount described in subsection
- 14 (d)(2)(A) which was received by the Postal Service
- during the period covered by such report; and
- 16 "(2) of the amount under paragraph (1), how
- much (in the aggregate and by category) was re-
- 18 quired for the purposes described in subsection
- 19 (d)(2)(B).
- 20 "(h) This section shall cease to be effective at the
- 21 end of the 2-year period beginning on the date on which
- 22 special postage stamps under this section are first made
- 23 available to the public.".
- 24 (b) Report by the Comptroller General of
- 25 THE UNITED STATES.—Not later than 3 months (but no

- 1 earlier than 6 months) before the end of the 2-year period
- 2 referred to in section 414a(h) of title 39, United States
- 3 Code (as amended by subsection (a)), the Comptroller
- 4 General of the United States shall submit to the Congress
- 5 a report on the operation of such section. Such report shall
- 6 include—
- 7 (1) an evaluation of the effectiveness and the 8 appropriateness of the authority provided by such
- 9 section as a means of fund-raising; and
- 10 (2) a description of the monetary and other re-11 sources required of the Postal Service in carrying
- out such section.
- 13 (c) Technical and Conforming Amendments.—
- 14 (1) Table of sections.—The table of sections
- for chapter 4 of title 39, United States Code, is
- amended by striking the item relating to section 414
- 17 and inserting the following:

- 18 (2) Section Heading.—The heading for sec-
- tion 414 of title 39, United States Code, is amended
- to read as follows:
