## A BILL

To revise the boundaries of the Golden Gate National  
Recreation Area, and for other purposes.

1 *Be it enacted by the Senate and House of Representa-*  
2 *tives of the United States of America in Congress assembled,*

3 **SECTION 1. SHORT TITLE.**

4 This Act may be cited as the “Golden Gate National  
5 Recreation Area Boundary Adjustment Act of 2000.”

1 **SEC. 2. ADDITIONS TO THE GOLDEN GATE NATIONAL**  
 2 **RECREATION AREA.**

3 Section 2(a) of the Act entitled “An Act to establish  
 4 the Golden Gate National Recreation Area in the State  
 5 of California, and for other purposes” (16 U.S.C. 460bb-  
 6 1(1)) is amended by adding at the end the following: “The  
 7 recreation area shall also include the land generally de-  
 8 picted on the map entitled ‘Additions to Golden Gate Na-  
 9 tional Recreation Area’, numbered NPS-80,073 and dated  
 10 January, 2000/PWR-PLRPC. All transactions concerning  
 11 the Golden Gate National Recreation Area shall involve  
 12 willing sellers and willing buyers.”.

13 **SECTION 1. SHORT TITLE.**

14 *This Act may be cited as the “Golden Gate National*  
 15 *Recreation Area Boundary Adjustment Act of 2000”.*

16 **SEC. 2. ADDITIONS TO THE GOLDEN GATE NATIONAL**  
 17 **RECREATION AREA.**

18 *Section 2(a) of the Act entitled “An Act to establish*  
 19 *the Golden Gate National Recreation Area in the State of*  
 20 *California, and for other purposes” (16 U.S.C. 460bb-1(a))*  
 21 *is amended by adding at the end the following: “The recre-*  
 22 *ation area shall also include the land, which may only be*  
 23 *acquired from willing sellers, generally depicted on the map*  
 24 *entitled ‘Additions to Golden Gate National Recreation*  
 25 *Area’, numbered NPS-80,076 and dated July 2000/PWR-*  
 26 *PLRPC.”.*
